Modification of Parcel Legal Description and Acreage Change

The parcel does not include the W2NW or the W2SW of section 23, reducing the acreage to approximately 479.29 acres in that section and the entire acreage of the parcel reduced to 3,679.29 acres.

Lease Notice

DL-3566 HQ-TES-1 Threatened and Endangered Species Act

The lease area may now or hereafter contain plants, animals, or their habitats determined to be threatened, endangered, or other special status species. The BLM may recommend modifications to exploration and development proposals to further its conservation and management objective to avoid BLM-approved activity that would contribute to a need to list such a species or their habitat. The BLM may require modifications to or disapprove proposed activity that is likely to result in jeopardy to the continued existence of a proposed or listed threatened or endangered species or result in the destruction or adverse modification of a designated or proposed critical habitat. The BLM will not approve any ground-disturbing activity until it completes its obligations under applicable requirements of the Endangered Species Act as amended, 16 U.S.C. § 1531 et seq. including completion of any required procedure for conference or consultation.

DL-3567 HQ-CR-1 Cultural Resource Protection

This lease may be found to contain historic properties and/or resources protected under National Historic Preservation Act (NHPA), American Indian Religious Freedom Act, Native American Graves Protection and Repatriation Act, E.O. 13007, or other statutes and executive orders. The BLM will not approve any ground-disturbing activities that may affect any such properties or resources until it completes its obligations under applicable requirements of the NHPA and other authorities. The BLM may require modification to exploration or development proposals to protect such properties, or disapprove any activity that is likely to result in adverse effects that cannot be successfully avoided, minimized, or mitigated.

DL-3568 HQ-MLA-1 Notice to Lessee Concerning Mineral Leasing Act Section 2(a)(2)(A)

Provisions of the Mineral Leasing Act (MLA) of 1920, as amended by the Federal Coal Leasing Amendments Act of 1976, affect an entity's qualifications to obtain an oil and gas lease. Section 2(a)(2)(A) of the MLA, 30 U.S.C. 201(a)(2)(A), requires that any entity that holds and has held a Federal Coal Lease for 10 years beginning on or after August 4, 1976, and that is not producing coal in commercial quantities from each such lease cannot qualify for the issuance of any other lease granted under the MLA. 43 CFR 3472 explains coal lessee compliance with Section 2(a)(2)(A).

In accordance with the terms of this oil and gas lease with respect to compliance by the initial lessee with qualifications concerning Federal coal lease holdings, all assignees and transferees are hereby notified that this oil and gas lease is subject to cancellation if: (1) the initial lessee as assignor or as transferor has falsely certified compliance with Section 2(a)(2)(A) because of a denial or disapproval by a State Office of a pending coal action, i.e., arms-length assignment,

relinquishment, or logical mining unit; (2) the initial lessee as assignor or as transferor is no longer in compliance with Section 2(a)(2)(A); or (3) the assignee or transferee does not qualify as a bona fide purchaser and, thus, has no rights to bona fide purchaser protection in the event of cancellation of this lease due to noncompliance with Section 2(a)(2)(A).

The lease case file, as well as in other Bureau of Land Management (BLM) records available through the State Office issuing this lease, contains information regarding assignor or transferor compliance with Section 2(a)(2)(A).

Other

DL-1439 MTH-NSO-05 Cultural Resources

As identified through tribal consultation, within areas of important natural, cultural, and archaeological value to tribes. This could include, but is not limited to, traditional cultural properties, sacred sites, burial sites, traditional/first foods, gathering areas, and culturally important plants. Additionally, if determined necessary through tribal consultation, areas proposed for geothermal exploration or development shall have a traditional plant survey undertaken to identify if any culturally important plants are present.

For the purpose of:

Protecting important natural, cultural, and archaeological resources, especially those identified by local tribes and through tribal consultation.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

On lands within boundaries of historic properties potentially eligible, eligible, or listed in the National Register of Historic Places, and additional lands outside the designated boundaries to the extent necessary to protect values where the setting and integrity is critical to their designation or eligibility.

For the purpose of:

Protecting and preventing adverse impacts to historic properties and associated cultural and archaeological resources that are potentially eligible, eligible, or listed in the National Register of Historic Places.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1441 MTH-CSU-10 Culture Resources

Exploration or development proposals shall adhere to the National Historic Preservation Act, American Indian Religious Freedom Act, Native American Graves Protection and Repatriation Act, Executive Order 13007, or other statutes and executive orders.

For the purpose of:

Protecting values and features of cultural and archaeological resources as they are subject to the acts and statutes listed above.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1442 MTH-TL-15 B11 Deer and Elk Summer Range

Within the B11 Deer and Summer Elk Range Management Area, as designated by the Mt. Hood National Forest Plan, activities will be limited during fawning, calving, and rearing season, which is from April 1 through July 30.

For the purpose of:

Protecting high quality summer rearing habitat for deer and elk.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1443 MTH-NSO-07 B2 Scenic Viewsheds

On lands within the foreground area of the B2 Scenic Viewshed Management Area or Designated Viewshed, as designated by the Mt. Hood National Forest Plan.

For the purpose of:

Protecting attractive, visually appealing forest scenery with a wide variety of natural appearing landscape features within areas designated B2 Scenic Viewsheds.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1444 MTH-NSO-06 B12 Backcountry Lake Area

On lands within the B12 Backcountry Lakes Management Area, as designated by the Mt. Hood National Forest Plan.

For the purpose of:

Protecting and enhancing the recreation, fish and wildlife, and scenic of designated lakes.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1445 MTH-NSO-03 Slopes > 40 percent

On lands with slopes greater than 40 percent and/or soils with high erosion potential. Protecting soil resources from loss of productivity and stability; preventing the (re)activation of landslides; and preventing erosion on steep slopes, soil mass movement, and resultant sedimentation.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1446 MTH-NSO-02 Riparian Reserves and A9 Areas

On lands within the A9 Key Site Riparian Area management area, as designated by the Mt. Hood National Forest Plan; and riparian reserves, as defined by the Northwest Forest Plan, including water bodies, unstable and potentially unstable areas, wetlands, and 100-year floodplains.

For the purpose of:

Protecting and maintaining habitat and hydrologic conditions of selected riparian areas, notable for their exceptional diversity and high natural quality; protect riparian and aquatic habitat conditions for the sustained, long-term production of fish, selected wildlife and plant species, and high-quality water for riparian and aquatic areas.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1447 MTH-CSU-12 B2 Scenic Viewsheds

Facilities and activities (including clearings, roads, utilities, and structures) within the B2-Scenic Viewshed Management Area or Designated Viewshed shall be located and designed and/or modified to blend with the natural landscape character. All activities shall meet the NFS Visual Management System designations for all distance zones within the management area and designated viewshed.

For the purpose of:

Protecting attractive, visually appealing forest scenery with a wide variety of natural appearing landscape features within areas designated B2 Scenic Viewsheds.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1448 MTH-CSU-09 Slope > 30 Percent

Exploration and development proposals shall not have adverse impacts on erosive soils as defined as severe or very severe erosion classes based on the Mt. Hood National Forest Soil Resource Inventory (1979).

For the purpose of:

Protecting soil resources from loss of productivity; preventing re-activation of landslides; and preventing erosion on steep slopes, soil mass movement, and resultant sedimentation. Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1449 MTH-CSU-07 Riparian Reserves et al

Within approximately 500 feet of riparian, wetland vegetation, or major groundwater recharge area, exploration and development proposals shall protect the values and functions of these areas.

For the purpose of:

Protecting the biological and hydrologic values and functions of water bodies, riparian reserves, wetlands, and groundwater recharge areas.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1450 MTH-CSU-08 LSRs and Old-Growth Forest

Exploration and development proposals shall minimize detrimental effects to late successional reserves and old-growth forest conditions.

For the purpose of:

Protecting the biological and ecological values and functions of late-successional reserves and old-growth forests, including wildlife and plant habitat, ecosystem diversity, preservation of aesthetic quality, and opportunities for human-forest interaction.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1451 MTH-CSU-TL-14 Important Habitat et al

Within important habitat and migration corridors, there should be modifications to exploration and development proposals to protect the continuity of migration corridors and important habitat.

For the purpose of:

Protecting the continuity of important habitat and wildlife migration corridors.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.

DL-1452 MTH-CSU-TL-13 Sensitive Species et al

For agency-designated species and habitat, there should be modifications to exploration and development proposals to ensure species and habitat conservation objectives and to ensure an

activity would not contribute to a need to list such a species or their habitat under the Endangered Species Act.

For the purpose of:

Protecting habitat and populations of agency-designated wildlife and plant species and to meet conservation objectives under the Endangered Species Act.

Any changes to this stipulation will be made in accordance with the land use plan and/or the regulatory provisions for such changes.
