BLM FUELWOOD PRODUCT PERMIT BY MAIL INSTRUCTIONS

- 1. On this webpage you will find an example form 5450-24, a blank form 5450-24, a blank BLM Forest Wood Product Cutting Permit Special Provisions, a map of the Kemmerer Field Office, and this instruction sheet.
- 2. In order to receive a personal use fuelwood permit by mail download and print form 5450-24, and the Cutting Permit Special Provisions, fill them out and sign them using the instructions on this sheet and referencing the example form 5450-24. Then mail them along with your payment in the form of a check to the Kemmerer Field Office at the address below.

- 3. The price for each cord of fuelwood you intend to harvest off of BLM managed lands is \$5.00, additionally for each cord of fire wood you purchase a \$1.00 road maintenance fee will be charged.
- 4. A minimum purchase quantity has been set at four (4) cords the maximum is ten (10) cords.
- 5. No cutting shall occur before May 1st. This permit shall terminate on midnight of November 15th or when the quantity of fuelwood sold has been reached, whichever comes first.

Instructions:

1. For form (5450-24)

Use the example form provided to assist in filling out a blank 5450-24 form.

- a. In the Permittee's Name and Complete Address section:
 - 1. Fill in your name.
 - 2. Fill in your complete mailing address.
- b. In the County section:
 - 1. Fill in the county name where the permit area is located.
- c. In the Permit Area Description:
 - 1. Fill in a description of the area you intend to harvest fuelwood at.
- d. Product Designation Section:
 - 1. Under Products write (Wood Products).
 - 2. Under Species write (Fuelwood).
 - 3. Under Unit of Measure write (Cords).
 - 4. Under Quantity Sold indicate the number of cords you are purchasing. Note: Minimum of 4 cords required
 - 5. Under Rate Per Products UOM write (\$5.00)
 - 6. Under Associated Charges Write (\$1.00) Note: this is a road maintenance fee.
 - 7. Under Total Cost of Products multiply the Rate Per Product UOM (\$5.00) by the Quantity Sold (X)
 - 3. Under the Cost of Assoc. Charges (\$) multiply the Quantity sold (X) by the Assoc. Charges \$ per UOM (\$1.00)
 - 9. Under Total Permit Costs Enter the amount computed for Total Cost of Products (\$) above
 - 10. Under Total Purchase Price add the Total Permit Costs to the Cost of Associated Charges (\$)
 - 11. Write a check made payable to the Bureau of Land Management for the amount contained in the Total Purchase Price and send it to the address of the BLM Field Office listed above. Note: Please include your phone number in the comments section of the check so that if any problems arise we can contact you for clarification.
 - 12. Under Signatures Sign above the line labeled Permittee.

- 13. Under signatures enter todays date above the line labeled Date.
- 14. Please send BLM form 5450-24 with all information requested in parts 1-13 above to the address of the BLM Field Office listed above. Also include BLM Forest Wood Product Cutting Permit Special Provisions; the directions are listed below in step 2.
- 2. For Form (BLM Forest Wood Product Cutting Permit Special Provisions)
- Please read, understand, and adhere to all special provisions detailed on BLM Forest Wood Products Cutting Special Provisions form.
- b. Sign the form above the line marked signature at the bottom of the last page.
- c. Put todays date above the line marked date at the bottom of the last page.
- d. Please mail the form along with your check and the completed 5450-24 form to the BLM Field Office at the address listed above.
- 6. Once we have received your signed Form 5450-24, check, and signed Special Provisions we will enter the information into our computer system and print you a completed permit. This permit will be signed by our Authorized Officer giving you proof of your ability to harvest fuelwood off of BLM managed lands. This signed permit along with the required number of load tickets will be returned to you via mail.

GENERAL CONDITIONS

Subject to, and in strict compliance with, all the following conditions (both General and Other) and those listed above, the Permittee named herein is authorized to harvest and remove the forest products described above.

- 1. This sale is final and payments are not subject to refund.
- 2. Permit must be in the Permittee's possession while harvesting and transporting products. Copies are not allowed.
- 3. This permit is nontransferable.
- 4. This permit and activities hereunder are subject to all applicable Federal statutes and regulations and State and local laws. In case of conflict, Federal statutes and regulations shall take precedence. Where applicable, a Memorandum of Agreement between the Forest Service and BLM governs administration and enforcement of this permit (Sec. 330, P.L. 106-291).
- 5. Motorized vehicles are not allowed off existing roads that are open to the public, unless otherwise specified within this permit. Permittee parking shall not block traffic or impede fire or emergency vehicles.
- 6. Permittee shall remove all trash and litter resulting from Permittee's activities.
- 7. Concurrent with forest product removal activities, slash and unused vegetative material resulting from Permittee's activities shall be removed from roads and ditches and scattered in the surrounding landscape.
- 8. Permittee shall comply with fire requirements and current restrictions to prevent forest fires.
- 9. Permittee shall pay for or repair all damage to natural features; riparian areas; other vegetation; and roads, trails, fences, ditches, telephone lines, or other improvements resulting from Permittee's activities under this permit.
- 10. The Forest Service and/or BLM reserve the right to unilaterally revoke this permit for Permittee's noncompliance with its terms and conditions or when revocation is in the public's interest.
- 11. Regardless of whether forest products are removed, this permit will terminate either at midnight of the termination date shown above, or when the quantity listed above is reached, whichever comes first.
- 12. None of the terms or conditions of this permit may be varied or modified, except for unilateral modifications by the Forest Service and/or BLM.
- 13. Permittee agrees to hold the Government harmless from any claim for damage or loss of property, personal injury, or death.
- 14. Collection of forest products is permitted only in the area(s) described by this permit.
- 15. Permittee shall complete the Product Quantity Removal Record in ink prior to transporting products. When load tickets are issued, the Permittee is required to complete load tickets when Permittee moves between collection sites or leaves a permit area. Load tickets must be securely attached to the load and clearly visible from the rear of the vehicle.
