Tim-

I'm looping in Utah's Budget Staff. I know that the original MLR Base for GSENM was \$4,886,800 but will have to get final \$\$ from Randy or Tiffany. Do they need other small amounts like the NLCS grants that were funded by the WO mid-year?

Because BENM was designated in December, we didn't re-program any L1711 dollars to Bears Ears in FY17 (or FY18, for that matter). Thus, we cannot separate out the funds that were obligated by the field office versus the funds that were obligated within the monument.

Perhaps we should have a brief call this morning to establish what exact information you need us to pull?
