- 1. OFFICIAL DESIGNATION:** Bears Ears National Monument Advisory Committee (Committee).
- 2. AUTHORITY:** This Committee is established pursuant to the Presidential Proclamation, "Establishment of the Bears Ears National Monument (Monument)," (December 28, 2016), and is consistent with Section 309 of the Federal Land Policy and Management Act (FLPMA), as amended, (43 U.S.C. 1739); the Forest and Rangeland Renewable Resources Planning Act of 1974 (16 U.S.C. 1600); Section 14 of the National Forest Management Act of 1976 (16 U.S.C. 472a); the Wilderness Act (16 U.S.C. 1131); and all other applicable provisions of law. The Bureau of Land Management (BLM) is subject to standards and procedures for the creation, operation, and termination of BLM resource advisory councils. Refer to the 1995 amended BLM regulations (43 CFR 1784) for specific regulations regarding: avoidance of conflict of interest (1784.2 2); calls for nominations (1784.4 1); notice of meetings (1784.4 2); open meetings (1784.4 3); records (1784.5 3); and course of instruction for members (1784.6 1(f)). The Committee is regulated by the Federal Advisory Committee Act (FACA), as amended, 5 U.S.C. Appendix 2.
- 3. OBJECTIVES AND SCOPE OF ACTIVITIES:** The Committee will provide information and advice regarding the development of the management plan and, as appropriate, management of the Monument to the Secretary of the Interior, through the Director of BLM, and the Secretary of Agriculture through the Chief of the U.S. Forest Service (FS), as stated in the Presidential Proclamation establishing the Monument.
- 4. DESCRIPTION OF DUTIES:** Committee duties and responsibilities are solely advisory in nature. The Committee will provide information and advice regarding the development of the Monument's management plan, and as appropriate, management of the Monument as stated in the Presidential Proclamation establishing the Monument.
- 5. OFFICIAL TO WHOM THE COMMITTEE REPORTS:** The Committee reports to the Secretary of the Interior, through the Director of BLM, and the Secretary of Agriculture, through the Chief of the FS.

Members may be appointed as representative members or special Government employees. Members appointed as special Government employees are required to complete ethics training and file a confidential financial disclosure report on an annual basis.

- 13. ETHICS RESPONSIBILITIES OF MEMBERS:** No Committee or subcommittee member will participate in any specific party matter including a lease, license, permit, contract, claim, agreement, or related litigation with the Departments of the Interior or Agriculture in which the member has a direct financial interest. Members of the Committee shall be required to disclose to the DFO their direct or indirect interest in leases, licenses, permits, contracts, claims, grants, or any specific party matter that involve lands or resources administered by BLM or FS, or any litigation related to those matters.

For the purposes of this paragraph, indirect interest includes holdings of a spouse, minor child, immediate family member, relatives, business partners, or employers that would benefit financially from the Committee's recommendations. The DFO must report any required disclosures under this paragraph to the BLM Deputy Ethics Counselor, who will coordinate with the Departments of the Interior or Agriculture Ethics Office as appropriate.

The Department of the Interior will provide materials to those members appointed as special Government employees, explaining their ethical obligations with which the members should be familiar. Consistent with the ethics requirements, members will endeavor to avoid any actions that would cause the public to question the integrity of the Committee's operations, activities, or advice. The provisions of this paragraph do not affect any other statutory or regulatory ethical obligations to which a member may be subject.

- 14. SUBCOMMITTEES:** Subject to the DFO's approval, subcommittees may be formed for the purposes of compiling information or conducting research. However, such subcommittees must act only under the direction of the DFO and must report their recommendations to the full Committee for consideration. Subcommittees must not provide advice or work products directly to the Agency. Subcommittees will meet as necessary to accomplish their assignments, subject to the approval of the DFO and the availability of resources.
- 15. RECORDKEEPING:** The records of the Committee, and formally and informally established subcommittees of the Committee, shall be handled in accordance with General Record Schedule 6.2, and other approved Agency records disposition schedule. These records shall be available for public inspection and copying, subject to the Freedom of Information Act, 5 U.S.C. 552.

**SUMMARY:** The Bureau of Land Management (BLM) gives notice that the Secretary of the Interior is establishing the Bears Ears National Monument (Monument) Advisory Committee (Committee). This notice also solicits nominations for members of the public to sit on the Committee. The Committee will provide information and advice regarding the development of the Monument's management plan and, as appropriate, management of the Monument to the Secretary of the Interior, through the Director of BLM, and the Secretary of Agriculture, through the Chief of the U.S. Forest Service, as stated in the Presidential Proclamation establishing the Monument.

**SUPPLEMENTARY INFORMATION:** The Federal Land Policy and Management Act (FLPMA; 43 U.S.C. §§ 1701 *et seq.*), directs the Secretary of the Interior to involve the public in planning and issues related to management of lands administered by the BLM. The rules governing BLM Advisory Committees are found at 43 CFR subpart 1784. As required by the Federal Advisory Committee Act, Advisory Committee membership must be balanced and representative of the various interests concerned with the management of the public lands. The Committee will be composed of 12 members:

1 elected official from San Juan County; 1 member representing State government; 1 member with paleontological expertise; 1 member with archaeological and historic expertise; 1 member representing the environmental community; 1 member representing the livestock grazing permittees within the Monument; 1 public at large member; 1 member representing tribal interests; 2 members representing developed outdoor recreation, off highway vehicle users, or commercial recreation activities; 1 member representing local business owners; and 1 member representing private landowners.

Individuals may nominate themselves or others. The BLM will evaluate nominees based on their education, training, experience, and/or knowledge of the geographic area of the Monument.

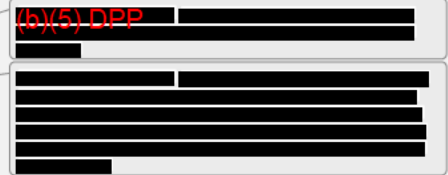

- A completed background information nomination form; and
- Any other information that addresses the nominee's qualifications.

1. **OFFICIAL DESIGNATION:** Bears Ears National Monument Advisory Committee (Committee).
2. **AUTHORITY:** This Committee is established pursuant to the Presidential Proclamation, "Establishment of the Bears Ears National Monument (Monument)," (December 28, 2016), and is consistent with Section 309 of the Federal Land Policy and Management Act (FLPMA), as amended, (43 U.S.C. 1739); the Forest and Rangeland Renewable Resources Planning Act of 1974 (16 U.S.C. 1600); Section 14 of the National Forest Management Act of 1976 (16 U.S.C. 472a); the Wilderness Act (16 U.S.C. 1131); and all other applicable provisions of law. The Bureau of Land Management (BLM) is subject to standards and procedures for the creation, operation, and termination of BLM advisory committees. Refer to the 1995 amended BLM regulations (43 CFR 1784) for specific regulations regarding: avoidance of conflict of interest (1784.2-2); calls for nominations (1784.4-1); notice of meetings (1784.4-2); open meetings (1784.4-3); and records (1784.5-3). The Committee is regulated by the Federal Advisory Committee Act (FACA), as amended, 5 U.S.C. Appendix 2.
3. **OBJECTIVES AND SCOPE OF ACTIVITIES:** The Committee will provide information and advice regarding the development of the management plan and, as appropriate, management of the Monument to the Secretary of the Interior, through the Director of BLM, and the Secretary of Agriculture, through the Chief of the U.S. Forest Service (FS), as stated in the Presidential Proclamation establishing the Monument.
4. **DESCRIPTION OF DUTIES:** Committee duties and responsibilities are solely advisory. The Committee will provide information and advice regarding the development of the Monument's management plan, and as appropriate, management of the Monument as stated in the Presidential Proclamation establishing the Monument.
5. **OFFICIAL TO WHOM THE COMMITTEE REPORTS:** The Committee reports to the Secretary of the Interior, through the Director of BLM, and the Secretary of Agriculture, through the Chief of FS.

6. **SUPPORT:** Administrative support and funding for activities of the Committee will be provided by BLM through the office of the Designated Federal Officer (DFO).
7. **ESTIMATED ANNUAL OPERATING COSTS AND STAFF YEARS:** The annual operating costs associated with supporting the Committee's activities are estimated to be \$50,000, including all direct and indirect expenses and 0.30 Federal staff years support.
8. **DESIGNATED FEDERAL OFFICER:** The DFO is BLM's Canyon Country District Manager, who is a full-time Federal employee appointed in accordance with Agency procedures. The DFO will approve or call all Committee and subcommittee meetings, prepare and approve all meeting agendas, attend all Committee and subcommittee meetings, adjourn any meeting when the DFO determines adjournment to be in the public interest, and chair meetings when directed to do so by the Secretary.
9. **ESTIMATED NUMBER AND FREQUENCY OF MEETINGS:** The Committee will meet approximately two to four times annually, and at such other times as designated by the DFO.
10. **DURATION:** Continuing.
11. **TERMINATION:** The Committee will terminate on December 28, 2018, unless, prior to that date, it is extended by the President. However, the Charter will expire two years from the date the Charter is filed, unless it is renewed in accordance with Section 14 of the FACA. The Committee will not meet or take any action without a valid current charter.
12. **MEMBERSHIP AND DESIGNATION:** The Committee shall include 12 members to be appointed by the Secretary of the Interior and the Secretary of Agriculture, as follows:
  - 1) An elected official from San Juan County;
  - 2) A representative of State government;
  - 3) A representative with paleontological expertise;
  - 4) A representative with archaeological or historic expertise;
  - 5) A representative of the environmental community;
  - 6) A representative of livestock grazing permittees within the Monument;
  - 7) A representative of tribal interests;
  - 8) Two representatives of developed outdoor recreation, off-highway vehicle users, or commercial recreation activities;
  - 9) A representative of private landowners;
  - 10) A representative of local business owners; and
  - 11) A representative of the public-at-large.

Members will be appointed to staggered 3-year terms. All members serve at the discretion of the Secretary of the Interior and the Secretary of Agriculture.

Members may be appointed as representative members or special Government employees. Members appointed as special Government employees are required to complete ethics training and file a confidential financial disclosure report on an annual basis.

**CHARTER**

- 1. OFFICIAL DESIGNATION:** Grand Staircase-Escalante National Monument Advisory Committee (Committee).
- 2. AUTHORITY:** The Committee is a discretionary advisory committee established under Section 309 of the Federal Land Policy and Management Act (FLPMA), as amended (43 U.S.C. 1739). The Bureau of Land Management (BLM) is subject to standards and procedures for the creation, operation, and termination of BLM resource advisory councils. Refer to the 1995 amended BLM regulations (43 CFR 1784) for specific regulations regarding avoidance of conflicts of interest (1784.2-2); calls for nominations (1784.4-1); notice of meetings (1784.4-2); open meetings (1784.4-3); records (1784.5-3); course of instruction for members (1784.6-1(f)); and quorum requirements (1784.6-1(h)). The Committee is regulated by the Federal Advisory Committee Act (FACA), as amended, 5 U.S.C. Appendix 2.
- 3. OBJECTIVES AND SCOPE OF ACTIVITIES:** The Committee will advise the Secretary of the Interior (Secretary) on science and other management issues and the achievement of Grand Staircase-Escalante National Monument Management Plan (Management Plan) objectives.
- 4. DESCRIPTION OF DUTIES:** Committee duties and responsibilities are as follows:
  - a. To develop recommendations for the Monument on issues pertaining to science and other management issues, and the achievement of objectives set forth in the Management Plan.
  - b. Specifically, the Committee may be requested by the Designated Federal Officer (DFO) to:
    - (1) gather and analyze information, conduct studies and field examinations, seek public input, or ascertain facts to develop recommendations concerning the use and management of the Monument;
    - (2) review programmatic documents including the annual Monument Manager's Reports, Quarterly Division Reports, and Monument Science Plans to provide recommendations on the achievement of the Management Plan objectives;

- (3) compile monitoring data and assess and advise the DFO of the extent to which the Plan objectives are being met;
  - (4) make recommendations on Monument protocols and applicable planning projects to ensure the overall objectives are being met;
  - (5) review appropriate research proposals and make recommendations on project necessity and validity;
  - (6) make recommendations regarding allocation of research funds through review of research and project proposals as well as needs identified through the evaluation process;
  - (7) consult and make recommendations on issues such as protocols for specific projects, e.g., vegetation restoration methods or standards for excavation and curation of artifacts and objects; and/or
  - (8) prepare an annual report summarizing the Committee's activities and accomplishments of the past year and make recommendations for future needs and activities.
5. **OFFICIAL TO WHOM THE COMMITTEE REPORTS:** The Committee provides advice to the Secretary through the DFO.
  6. **SUPPORT:** Administrative support and funding for activities of the Committee will be provided by BLM.
  7. **ESTIMATED ANNUAL OPERATING COSTS AND STAFF YEARS:** The annual operating costs associated with supporting the Committee's activities are estimated to be \$20,000, including all direct and indirect expenses and .15 Federal staff years support.
  8. **DESIGNATED FEDERAL OFFICER:** The DFO is BLM's Grand Staircase-Escalante National Monument Manager who is a full-time Federal employee appointed in accordance with Agency procedures. The DFO will approve or call all Committee and subcommittee meetings, prepare and approve all meeting agendas, attend all Committee and subcommittee meetings, adjourn any meeting when the DFO determines adjournment to be in the public interest, and chair meetings when directed to do so by the Secretary.
  9. **ESTIMATED NUMBER AND FREQUENCY OF MEETINGS:** The Committee will meet approximately two to four times annually and at such other times as designated by the DFO.
  10. **DURATION:** Continuing.

**11. TERMINATION:** The Committee will terminate 2 years from the date the Charter is filed, unless, prior to that date, the Charter is renewed in accordance with Section 14 of the FACA. The Committee will not meet or take any action without a valid current charter.

**12. MEMBERSHIP AND DESIGNATION:**


- a. Eight members will be appointed as follows, one from each of the categories listed below:
  - (1) an elected official from Garfield County, to represent the interests of county residents;
  - (2) an elected official from Kane County, to represent the interests of county residents;
  - (3) a representative of state government;
  - (4) a representative of tribal government with ancestral interest in the Monument;
  - (5) an educator, to represent the educational community;
  - (6) a representative of the environmental community;
  - (7) an outfitter and guide operating within the Monument, to represent commercial recreational users; and
  - (8) a livestock grazing permittee operating within the Monument, to represent grazing permittees.
- b. Seven members will be appointed as special Government employees, one for each of the following areas of expertise:
  - (1) archaeology
  - (2) paleontology
  - (3) geology
  - (4) botany
  - (5) wildlife biology
  - (6) social science
  - (7) systems ecology
- c. Members will be appointed to the Committee to serve 3-year terms.
- d. Members appointed as special Government employees are required to complete annual ethics training and may be required to file a confidential financial disclosure report.

13. **ETHICS RESPONSIBILITIES OF MEMBERS:** No Committee or subcommittee member will participate in any matter including a lease, license, permit, contract, claim, agreement, or related litigation with the Department in which the member has a direct financial interest.

As provided in 43 CFR 1784.2-2, members of the Committee shall be required to disclose their direct or indirect interest in leases, licenses, permits, contracts, or claims that involve lands or resources administered by BLM, or in any litigation related thereto. For the purpose of this paragraph, indirect interest includes holdings of a spouse or dependent child.

The Department of the Interior will provide materials to members appointed as special Government employees explaining their ethical obligations. Consistent with the ethics requirements, members will endeavor to avoid any actions that would cause the public to question the integrity of the Committee's operations, activities, or advice. The provisions of this paragraph do not affect any other statutory or regulatory ethical obligations to which a member may be subject.

14. **SUBCOMMITTEES:** Subject to the DFO's approval, subcommittees may be formed for the purposes of compiling information and conducting research. However, such subcommittees must act only under the direction of the DFO and must report their recommendations to the full Committee for consideration. Subcommittees must not provide advice or work products directly to the Agency. The Committee Chair, with the approval of the DFO, will appoint subcommittee members. Subcommittees will meet as necessary to accomplish their assignments, subject to the approval of the DFO and the availability of resources.
15. **RECORDKEEPING:** The Records of the Committee, and formally and informally established subcommittees of the Committee, shall be handled in accordance with General Record Schedule 6.2, and other approved Agency records disposition schedule. These records shall be available for public inspection and copying, subject to the Freedom of Information Act, 5 U.S.C. 552.

#### **INTRODUCTION**

The President of the United States Barack Obama designated the Bears Ears National Monument on Dec. 28, 2016. The Bureau of Land Management (BLM) and the US Forest Service (USFS) serve as co-managers of the monument. The Bears Ears National Monument Advisory Committee is a new committee, called for in the Dec. 28, 2017 Presidential proclamation establishing the Monument. BLM-Utah is recruiting for members to fill 12 positions. BLM-Utah will begin recruiting new members to help advise on the development of a management plan for the Bear Ears National Monument, per the Presidential Proclamation.

#### **PURPOSE**

The purpose is to recruit committee members and establish the Bears Ears National Monument Advisory Committee.

#### **COMMUNICATION GOALS**

- Share information on vacancies with all Committee interest groups.
- Build constituent group awareness about the work of the Committee and the opportunities for the public to become involved.

**CHARTER**

1. **OFFICIAL DESIGNATION:** Grand Staircase-Escalante National Monument Advisory Committee (Committee).
2. **AUTHORITY:** The Committee is a discretionary advisory committee established under Section 309 of the Federal Land Policy and Management Act (FLPMA), as amended (43 U.S.C. 1739). The Bureau of Land Management (BLM) is subject to standards and procedures for the creation, operation, and termination of BLM resource advisory councils. Refer to the 1995 amended BLM regulations (43 CFR 1784) for specific regulations regarding avoidance of conflicts of interest (1784.2-2); calls for nominations (1784.4-1); notice of meetings (1784.4-2); open meetings (1784.4-3); records (1784.5-3); course of instruction for members (1784.6-1(f)); and quorum requirements (1784.6-1(h)). The Committee is regulated by the Federal Advisory Committee Act (FACA), as amended, 5 U.S.C. Appendix 2.
3. **OBJECTIVES AND SCOPE OF ACTIVITIES:** The Committee will advise the Secretary of the Interior (Secretary) on science and other management issues and the achievement of Grand Staircase-Escalante National Monument Management Plan (Management Plan) objectives.
4. **DESCRIPTION OF DUTIES:** Committee duties and responsibilities are as follows:
  - a. To develop recommendations for the Monument on issues pertaining to science and other management issues, and the achievement of objectives set forth in the Management Plan.
  - b. Specifically, the Committee may be requested by the Designated Federal Officer (DFO) to:
    - (1) gather and analyze information, conduct studies and field examinations, seek public input, or ascertain facts to develop recommendations concerning the use and management of the Monument;
    - (2) review programmatic documents including the annual Monument Manager's Reports, Quarterly Division Reports, and Monument Science Plans to provide recommendations on the achievement of the Management Plan objectives;



- (3) compile monitoring data and assess and advise the DFO of the extent to which the Plan objectives are being met;
  - (4) make recommendations on Monument protocols and applicable planning projects to ensure the overall objectives are being met;
  - (5) review appropriate research proposals and make recommendations on project necessity and validity;
  - (6) make recommendations regarding allocation of research funds through review of research and project proposals as well as needs identified through the evaluation process;
  - (7) consult and make recommendations on issues such as protocols for specific projects, e.g., vegetation restoration methods or standards for excavation and curation of artifacts and objects; and/or
  - (8) prepare an annual report summarizing the Committee's activities and accomplishments of the past year and make recommendations for future needs and activities.
5. **OFFICIAL TO WHOM THE COMMITTEE REPORTS:** The Committee provides advice to the Secretary through the DFO.
  6. **SUPPORT:** Administrative support and funding for activities of the Committee will be provided by BLM.
  7. **ESTIMATED ANNUAL OPERATING COSTS AND STAFF YEARS:** The annual operating costs associated with supporting the Committee's activities are estimated to be \$20,000, including all direct and indirect expenses and .15 Federal staff years support.
  8. **DESIGNATED FEDERAL OFFICER:** The DFO is BLM's Grand Staircase-Escalante National Monument Manager who is a full-time Federal employee appointed in accordance with Agency procedures. The DFO will approve or call all Committee and subcommittee meetings, prepare and approve all meeting agendas, attend all Committee and subcommittee meetings, adjourn any meeting when the DFO determines adjournment to be in the public interest, and chair meetings when directed to do so by the Secretary.
  9. **ESTIMATED NUMBER AND FREQUENCY OF MEETINGS:** The Committee will meet approximately two to four times annually and at such other times as designated by the DFO.
  10. **DURATION:** Continuing.

**11. TERMINATION:** The Committee will terminate 2 years from the date the Charter is filed, unless, prior to that date, the Charter is renewed in accordance with Section 14 of the FACA. The Committee will not meet or take any action without a valid current charter.

**12. MEMBERSHIP AND DESIGNATION:**


- a. Eight members will be appointed as follows, one from each of the categories listed below:
  - (1) an elected official from Garfield County, to represent the interests of county residents;
  - (2) an elected official from Kane County, to represent the interests of county residents;
  - (3) a representative of state government;
  - (4) a representative of tribal government with ancestral interest in the Monument;
  - (5) an educator, to represent the educational community;
  - (6) a representative of the environmental community;
  - (7) an outfitter and guide operating within the Monument, to represent commercial recreational users; and
  - (8) a livestock grazing permittee operating within the Monument, to represent grazing permittees.
- b. Seven members will be appointed as special Government employees, one for each of the following areas of expertise:
  - (1) archaeology
  - (2) paleontology
  - (3) geology
  - (4) botany
  - (5) wildlife biology
  - (6) social science
  - (7) systems ecology
- c. Members will be appointed to the Committee to serve 3-year terms.
- d. Members appointed as special Government employees are required to complete annual ethics training and may be required to file a confidential financial disclosure report.

13. **ETHICS RESPONSIBILITIES OF MEMBERS:** No Committee or subcommittee member will participate in any matter including a lease, license, permit, contract, claim, agreement, or related litigation with the Department in which the member has a direct financial interest.

As provided in 43 CFR 1784.2-2, members of the Committee shall be required to disclose their direct or indirect interest in leases, licenses, permits, contracts, or claims that involve lands or resources administered by BLM, or in any litigation related thereto. For the purpose of this paragraph, indirect interest includes holdings of a spouse or dependent child.

The Department of the Interior will provide materials to members appointed as special Government employees explaining their ethical obligations. Consistent with the ethics requirements, members will endeavor to avoid any actions that would cause the public to question the integrity of the Committee's operations, activities, or advice. The provisions of this paragraph do not affect any other statutory or regulatory ethical obligations to which a member may be subject.

14. **SUBCOMMITTEES:** Subject to the DFO's approval, subcommittees may be formed for the purposes of compiling information and conducting research. However, such subcommittees must act only under the direction of the DFO and must report their recommendations to the full Committee for consideration. Subcommittees must not provide advice or work products directly to the Agency. The Committee Chair, with the approval of the DFO, will appoint subcommittee members. Subcommittees will meet as necessary to accomplish their assignments, subject to the approval of the DFO and the availability of resources.
15. **RECORDKEEPING:** The Records of the Committee, and formally and informally established subcommittees of the Committee, shall be handled in accordance with General Record Schedule 6.2, and other approved Agency records disposition schedule. These records shall be available for public inspection and copying, subject to the Freedom of Information Act, 5 U.S.C. 552.

**SUPPLEMENTARY INFORMATION:** The Federal Land Policy and Management Act (FLPMA; 43 U.S.C. §§ 1701 *et seq.*), directs the Secretary of the Interior to involve the public in planning and issues related to management of lands administered by the BLM. The rules governing BLM Advisory Committees are found at 43 CFR subpart 1784. As required by the Federal Advisory Committee Act, Advisory Committee membership must be balanced and representative of the various interests concerned with the management of the public lands. The Committee will be composed of 12 members;

1 elected official from San Juan County; 1 member representing State government; 1 member with paleontological expertise; 1 member with archaeological and historic expertise; 1 member representing the environmental community; 1 member representing the livestock grazing permittees within the Monument; 1 public at large member; 1 member representing tribal interests; 2 members representing developed outdoor recreation, off highway vehicle users, or commercial recreation activities; 1 member representing local business owners; and 1 member representing private landowners.

Individuals may nominate themselves or others. The BLM will evaluate nominees based on their education, training, experience, and/or knowledge of the geographic area of the Monument.

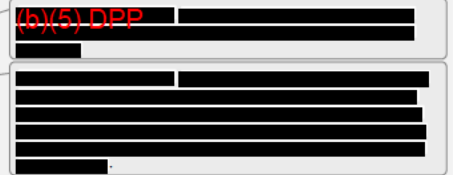
