Dear Mr. Zinke:

Congratulations on your new job. I loved seeing you ride to work on horseback.

I'm writing about the Bears Ears National Monument which I can see out my front porch in Bluff, Utah. I have lived in Bluff, Utah for 8 years, moving from Florida. San Juan County is the poorest county in Utah. Only 7 per cent of our land is private. I'm a Republican. I've enclosed a map of the monument, a San Juan County recreational guide and a recent San Juan County Record. The front page article about a judge stopping an ATV trail is a perfect example of why the BLM is held in disrespect. They love to close trails. It took them 12 years to approve the trail.

I was a charter member of Friends of Cedar Mesa and have been a Volunteer BLM State of Utah Archaeological Site Steward for five years, mostly on Cedar Mesa. Our group lost our \$5,000 funding but may get it in October. We have 40 stewards who monitor more than 100 ruins. We recently reported a group of Fort Lewis college students from Durango, Colorado. One student who wrote on a rock in Fishmouth Cave in Butler Wash was fined a whopping \$250. The school was fined nothing. The Colorado Archaeological Society yesterday posted a picture (see attached) of student performing yoga on mats in the cave. Somebody really dropped the ball on this. I would ask the BLM why.

The monument is basically too large at 1.3 million acres. I would reduce the size of the monument to extend from Grand Gulch to Butler Wash. Maybe 500,000 acres. At present, our County Landfill, the gravel pit and a Rocky Mountain power station are all included in the monument.

The monument is actually a reward for the Navajo Nation. Hence the name Bears Ears. The Navajos use their sacred mountain myth to claim land they never owned. The sites are 99% Hopi and Zuni. They abandoned the area in 1300. Lost in the picture is that Utah was named after the Ute Indians. The Friends of Cedar Mesa allegedly received more than \$1.5 million from the Leonardo Di Caprio Foundation.

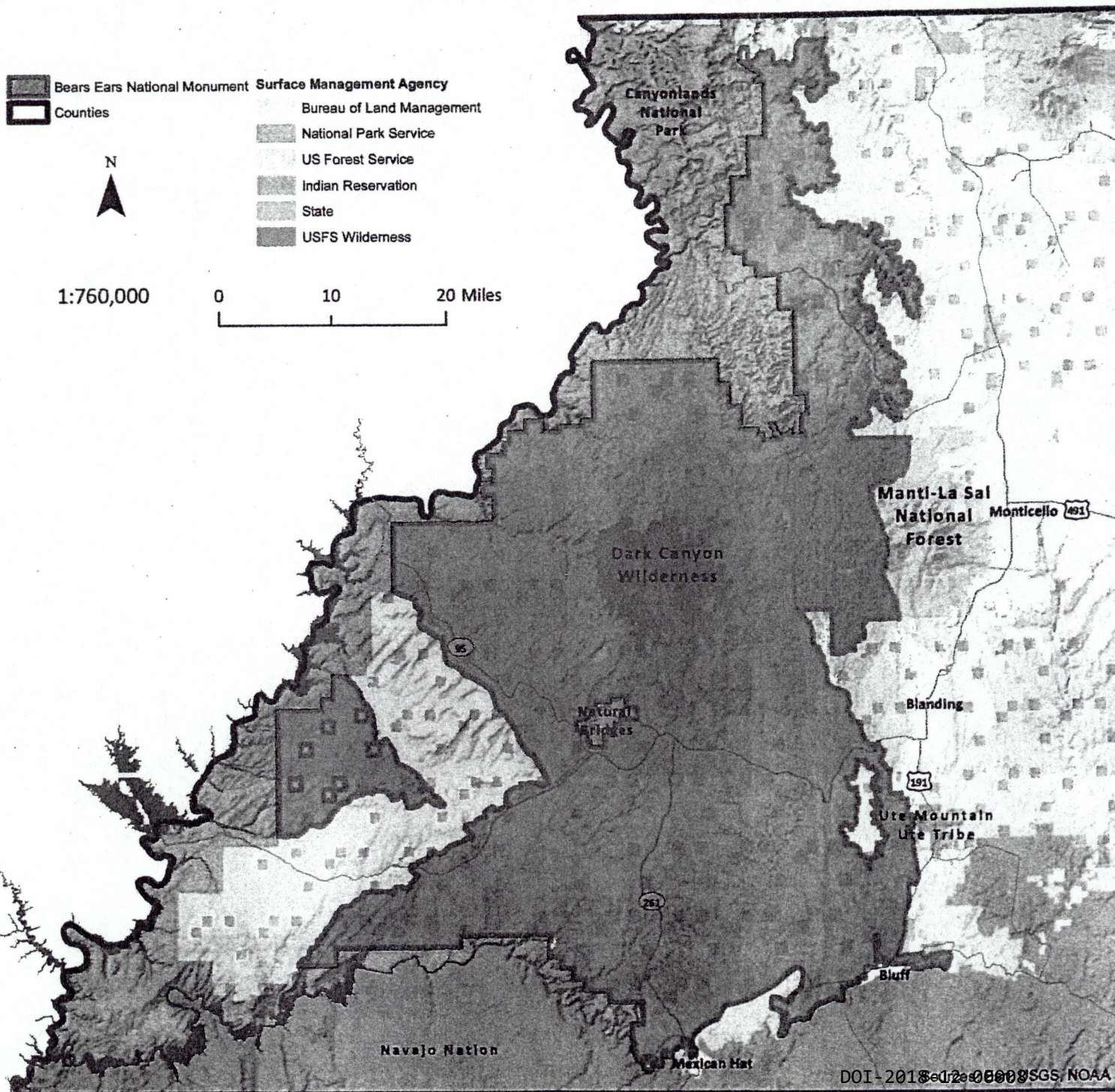
