Hi Brad --

As discussed, here's a copy of the updated DOI Comms/External/Congressional plan, subject to your edits. While it focuses on Utah, it includes other monuments as well, assuming you still want to release the Secretary's full report next week. We'd like to recommend the following:

1. Announce Utah on Monday, Dec. 4 with POTUS.

Questions:

A. Are you ok with our working with a local reporter to give them an exclusive? (b) (5) DPP
