Dear Associate Deputy Secretary Cason,

I appreciate the time you spent listening and discussing Bears Ears National Monument with the Bears Ears Inter-Tribal Coalition tribal leaders and myself on Thursday, May 25, 2017. In follow-up to the verbal invitation by Chairman Cuthair of the Ute Mountain Ute Tribe during our meeting, Utah Diné Bikéyah (UDB) now sends you the formal invitation in hopes that you, Secretary Zinke, and other key officials involved in the National Monuments review will attend our "Inter-Tribal Gathering." It will be held from Thursday, June 8<sup>th</sup> through Sunday, June 11<sup>th</sup> on Ute Mountain Ute lands located inside the Bears Ears National Monument. As stated, UDB also offers logistical support for DOI to hold a public meeting/listening session for San Juan County citizens during this event. Importantly, this meeting should happen in a location that is not hostile to Native Americans. As stated in our public comment submitted yesterday, Utah Diné Bikéyah strongly supports the Bears Ears National Monument in its entirety. 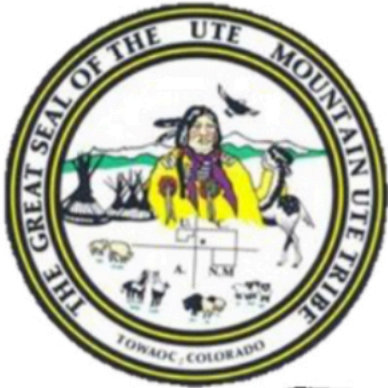
