The Secretary will be traveling to California and a few others states after July 10 to inspect several of the monuments under review. He has also received the attached letter from Congressman Cook suggesting changes changes to several monuments in his District, including San Gabriel.

Downey Magallanes, the Secretary's Deputy Chief of Staff and lead for the monument review. would like to have a briefing on San Gabriel, before July 10 if at all possible.

While the nature of the briefing is of course up to you, she is using an informal discussion approach in similar sessions with BLM, with some BLM staff in DC in her office and the State Director and other field staff calling in. We are not generating position papers for these briefings. Similarly, whether you want to participate or leave it to staff, and if the former, to come to Interior or have the briefing by phone, is your call. If you or Jennifer could let me know when things are ready I will put your scheduler in touch with Downey's to set a date and time.

Additionally, the letter raises one issue with respect to the Sand to Snow monument, but that is a management issue that does not seem to need addressing as part of the review.
