- DOI reorganization for the next 100 years
  - Coordinated with GPRA strategic plan and budget request
  - (b) (5) DPP [REDACTED]; low-cost reprogrammings in FY 17/18
  - Settling on the standard regions
  - Phasing and project plan for implementation of reorganization in FY18, FY19
  - Moving people from DC area to smaller cities seems to pay for itself in about 6 years

# Assistant Secretary Insular Areas

## Hurricane Response & Recovery – U.S. Virgin Islands

Met with FEMA Administrator Brock Long on Friday, September 22.

Response underway. Recovery starting. (First meeting held this week.)

Hurricane Irma/Maria Response: 135 DOI Personnel supporting the response under FEMA Mission Assignments. 89 of those are Law Enforcement officers providing assistance in PR/VI. They are DOI assets under direct control of FEMA/ATF. There are other DOI employees working in PR/VI for organic DOI missions.

Quick Response Teams deployed to Puerto Rico and USVI.

QRT 1: BLM - 25

QRT 2: FWS Refuge – 13, BLM – 4, NPS – 4, OIG – 2, OLES – 1

QRT 3: BLM 13, USPP 7, OLES – 3, NPS – 2, OIG - 1

QRT 4: BIA/Tribal - 14

Virgin Islands is still in RESCUE PHASE:

- Immediate needs to evacuate residents w/chronic medical needs
- Provide food, water, personal essentials to residents
- Clear debris from the roads
- Restore internet and cell service
- Restore electricity
- Stabilize the thousands of residential, commercial, and governments buildings that have lost roofs or otherwise been compromised.

The hurricane season in the Atlantic typically lasts through November.



# Assistant Secretary Insular Areas

Closing out 2017 grant operations.

OIA Discretionary Grants for 2018 to open on **www.grants.gov** the week of October 16, 2018.

This can serve as a conduit for emergency grant requests from the U.S. Virgin Islands.

OIA Funding will be provided under the short-term **continuing resolution** (Public Law 115-56) which ends December 8, 2017





# Assistant Secretary Insular Areas

## Current Operations – Territories

- AMERICAN SAMOA – In mid-October, OIA will award its first grant, an operational subsidy to the American Samoa Government, of approximately \$4 million, to support the local Department of Education, the hospital, and the judicial system.
- CNMI – The CNMI currently has an allowance of CW-1 visas of 12,998. Even with the recent enactment of H.R. 339, allowing an additional 350 CW-1 visas, it is well under the CNMI's estimated need of 18,000 workers. Note: The additional 350 CW-1 visas expire in four days. We continue to oppose DHS' plan to reduce CW workers to zero by 2019.

- The **local** KBE Atoll Government seeks to manage its own Bikini Resettlement Trust Fund for the People of Bikini. Spending limits are now determined by DOI/OIA.
- SOL to render a legal opinion on DOI/OIA next steps
