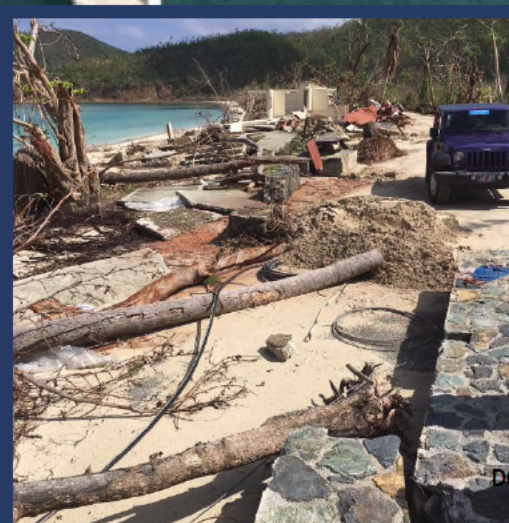
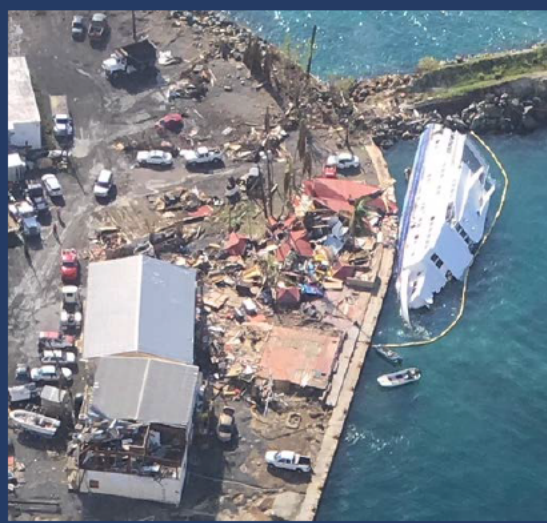

Hurricane Response & Recovery – U.S. Virgin Islands

- The Senate is moving forward on a \$36.5 billion emergency aid bill for communities ravaged by hurricanes and wildfire.
The bill (H.R. 2266) has passed House would also:
 - (1) make territories eligible for FEMA Disaster Assistance Direct Loans,
 - (2) removes the \$5 million cap on such loans, and
 - (3) provide \$150 million in loans to a territory to pay the local share of costs related to a major disasters.
- OMB is considering a \$608.5 million Interior hurricane appropriations proposal that would --
 - (1) \$585 million in moneys for the V.I. to provide the required 25% local match for FEMA programs,
 - (2) \$20 million for the V.I. to contract for the administration of FEMA grants, and
 - (3) \$3.5 million for OIA monitoring of FEMA funding and contractors.
- USVI Governor will be in Washington DC next week. USVI has proposed \$5.5 billion recovery.
- Puerto Rico Governor Rosselló was at WH last week with POTUS.

MEETING ON MILITARY BUILDUP – OIA met with the Governor of Guam and on CNMI. A key concern

GUAM – OIA met with a Guam Senator to discuss local legislation on potential tribal recognition for Chamorro natives, and other federal taxes that should be subject to remittance to Guam.

NORTHERN MARIANA ISLANDS – OIA met with CNMI Governor Torres to cover various issues. The Governor has asked DOD to put hold certain training activities proposed in CNMI and focus instead on “divert” infrastructure on Tinian.

Coconut Rhinoceros Beetles have been discovered on coconut trees in Rota – threatens to devastate a food source and cultural icon, similar to Guam. OIA is processing a \$180K emergency grant to deal with the invasive species.
