A couple of items from me, and I will defer to Harry & Matt for their additional or alternative input:

1. D. LWC Inventory Strike Team-both efforts: It will help to add a team lead/ GS 11 or 12 to this team to direct their efforts.
2. E. GSENM Staffing needs:

- I would also recommend a GS-13 for the Project Manager term position for GSENM. The level and complexity of this effort warrants the GS-13 and most of the leadership positions on GSENM are currently being filled by details.
- The Geologist is for the "Lands formerly known as GSENM" if that matters. This will be to assist with sand/gravel/oil & gas/coal applications as well as provide planning expertise or back-up for field work.
- Add a term GS-9 Paleontologist (1350) to provide back-up on field work/lab/etc as lone paleontologist will have additional planning responsibilities.
- Add a term GS-9 GIS 0301 GIS Specialist to provide back-up for planning effort.
- The additional Law Enforcement Officer would cover the Kaiparowits unit/ central part of the Monument/ Field Office.
- Add 3 Archaeology Survey Technicians- Term- to assist with the cultural survey work. 6 months of work.
- Add 3 NRS/Biologist technicians -Term- to complete critical surveys for baseline information.
