Greetings,

Please see below for an updated version of the timeline for the full analysis of National Monuments, including sending a sheet of I/O inputs to Josh S for his analysis. I've also added this to our Google Drive at National Monuments Review Data Call/PPA: "National Monuments Review 2017 - Gantt Charts".

We can come up with a few different approaches to dividing the monuments up among a group of authors. After Bears Ears and Grand Staircase (leaving out the marine monuments), we're left with 20 monuments. Grouping monuments by State and region we could try something

like the following:
