Looking for Detroit's Urban Landscape

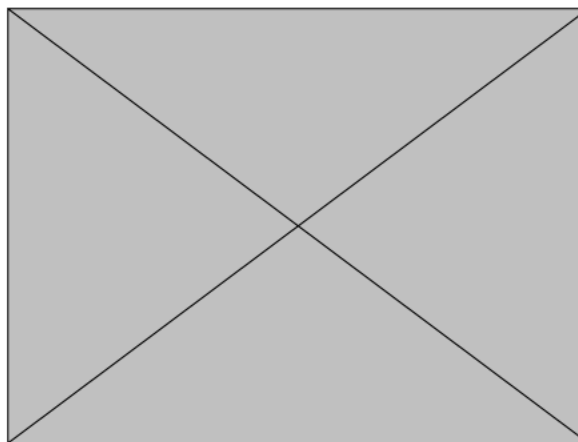
Over the past century, Detroit has served as a bellwether for the broader American economy, with its factories, many of which now stand vacant, offering tangible evidence of the county's booms and busts. Detroit's landscape is a complex text, offering insight into the rise and decline of American manufacturing, the after-effects of WWII, the Cold War, the Vietnam War, racism and classism. The city also has a rich cultural heritage that is still visible and vibrant. DOI Landscape Program zeroed out

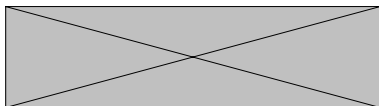
