Hi again, Chris,

Attached please find the table with the updated acreage figures. All changes are in red.

In three cases - Ironwood Forest, Rio Grande del Norte, and Bears Ears - the acreages in the updated table differ slightly from those in the recently produced monument closures table. (Sally had me do a cross-check with this table as well.) These minor acreage discrepancies are extremely common and stem from the fact that different offices have different ways of calculating acreages (GIS, land use plans, etc.). Additionally, sometimes units change in size by a few acres, and it takes the WO or the State Office some time to process those changes.

Hi Chris,

Sure thing! Here is my recommended response:

BLM does not include non-Federal (State and private) lands in our monument acreage tallies. Only Federal lands count toward the total acreage figures. Therefore, we do not recommend adding the "State and Private lands" column figures to the "Federal lands" column figures.

Additionally, some of these acreage figures differ from those in our current database. We would be happy to send our latest acreage figures over, but since I do not know where these figures came from, I did not want to make changes directly to the table.

To determine the current total acreage of a monument on the list, do the "number of acres at enactment" (H) column and the "current non-federal acreage" column (J) need to be added together? I wanted to clarify so that a correct tally of total current acres can be determined.

Also, in cases where the current federal acreage has changed (captured in column "i"), I think that we would add this column with "current non-federal acreage" column (J), to tally the total current acres. Is that correct?

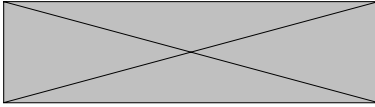

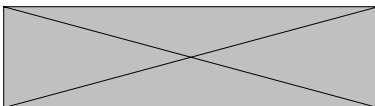
