Sally-

BLM-Utah has no concerns with to the request related to SO 3356 and WO 410's recommendations.

Utah's only closures within the two national monuments are under the generic CFRs that prohibit the discharge of firearms within developed recreation sites. We do not have any land use planning level decisions related to restrictions on target shooting, hunting or fishing within the Monticello RMP or the

GSENM MMP. In the case of Bears Ears, we are already directed under the existing proclamation to initiate a new land use plan.

Our assumption is that if any changes are made as a result of action on the Monument review, then we will likely need to initiate a land use plan amendment or revision for GSENM as well. So, if we're in a situation where land use plan amendments are already pending, we could certainly easily incorporate any new guidance related to hunting and fishing opportunities.

Information included in the table is listed by State and National Monuments for those monuments with (1) both hunting and recreational shooting restrictions and closures; (2) those with recreational shooting restrictions or closures; or (3) those with no hunting or recreational shooting restrictions or closures.

We would like your review to (1) make sure we correctly captured the information we already gathered from your State; (2) ensure that we provided appropriate planning recommendations; (3) address items noted in red text that ask for reference/citation information; and (4) request your input about specific opportunities to improve and expand hunting, fishing, recreational shooting, and access in national monuments.
