 - On August 16 the region-wide Gulf of Mexico lease sale generated \$121,143,055 in high bids for 90 tracts covering 508,096 acres in federal waters of the Gulf of Mexico. A total of 27 companies participated in the sale, submitting 99 bids totaling \$137,006,181.
- **New Five Year Program:**
 - BOEM published the Request for Information, which began the public process for developing a new Five Year Program, in the Federal Register on July 3. The comment period closed on Aug. 17. As of Aug. 22, BOEM had received approximately 815,000 comments. BOEM has been holding virtual meetings on the development process and outreach continues with the states.

Separately, on June 22, 2017, CWA submitted a second request for a 2-year lease term and rent payment suspension. On July 24, 2017, CWA's approved lease suspension expired. BOEM is reviewing CWA's request for a second suspension.
