I've got is sorted by commenter count, but since its in Excel, it can be sorted in many ways.

There's a link to the actual comment on [regs.gov](#). I've looked at every attachment that wasn't an image file to validate the number of commenters represented.

I also indicated the records that are full of postcards/letters to Obama.

What should happen is that each of these records should be opened in FDMS and enter the number of commenters in the field that records that data. Every time you do that, the number in the upper corner of [regs.gov](#) will go up by that count. (That number is refreshed only once a day at midnight, so it would be the next day you would see this happen.)

Next we tackle the remaining records.
