



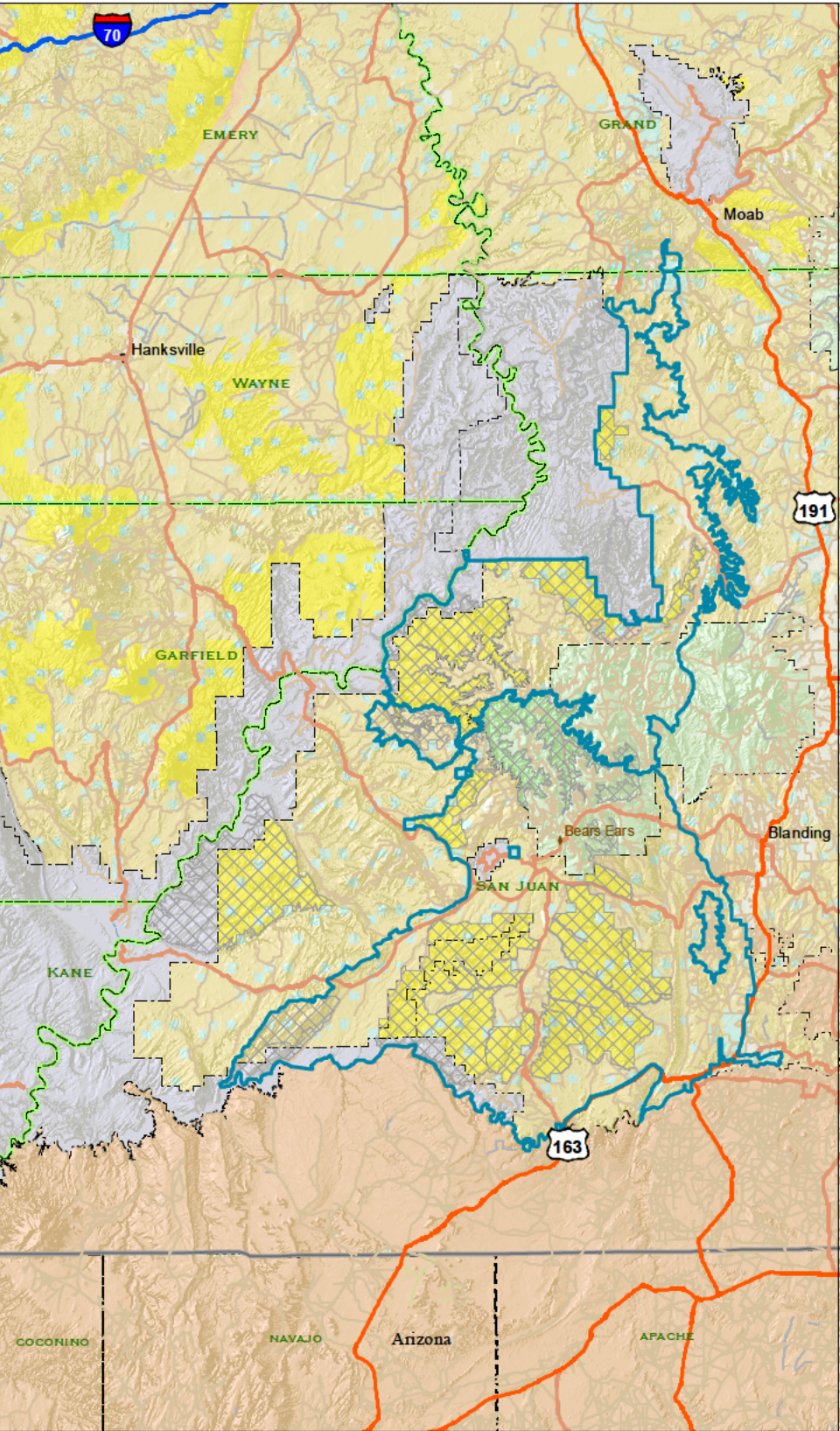
Bears Ears National Monument

Intertribal Coalition Proposed Boundary



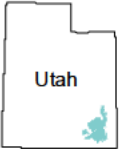
