Dear President Trump,

On behalf of the Navajo Nation, we write to request a meeting with you to discuss Bears Ears National Monument. Bears Ears National Monument holds sacred religious and cultural significance to our people and as such, we are gravely concerned with Secretary Ryan Zinke's recommendations to you regarding the Bears Ears National Monument.

We strongly support maintaining the Bears Ears National Monument as it currently exists, and we are not alone in our sentiment. Some 2.8 million Americans including five local Native American Nations commented in support of Bears Ears and other national monuments, and many noted the economic benefits Bears Ears will bring to the surrounding region.

We respectfully request to meet with you on a government-to-government basis to share our story and our concerns as they relate to Bears Ears National Monument. The Navajo Nation thanks you for your time and consideration of our request to consult with you.
