Individuals and organizations represented all sides of the debate ranging from environmental organizations like the Wilderness Society and Nature Conservancy to county commissioners and, residents, and ranchers who prefer multiple use of the land. The Secretary also met with Tribal government representatives and the Department hosted several Tribal listening sessions.
