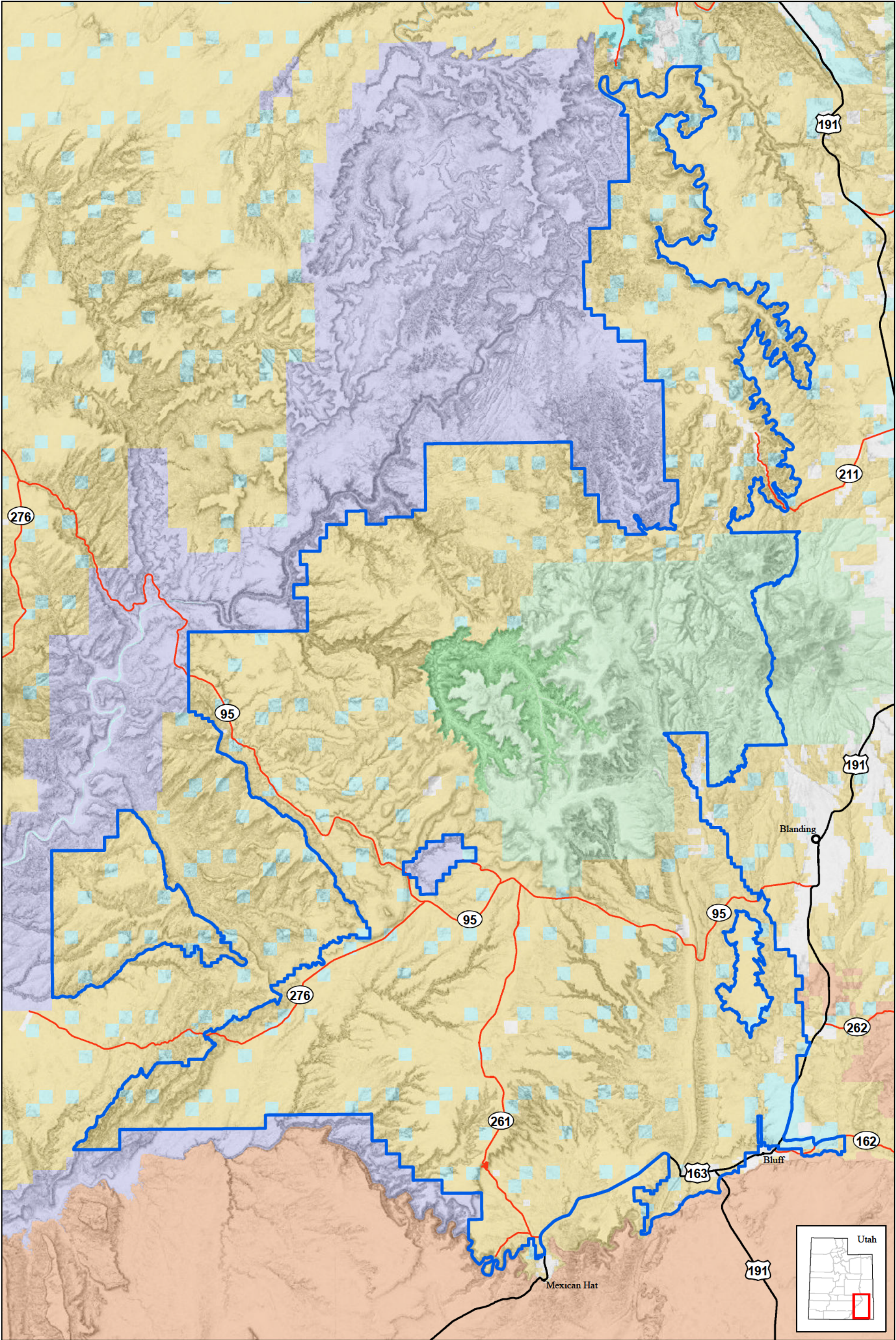

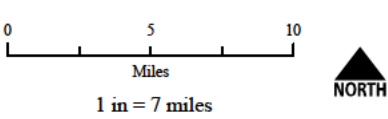


# Bears Ears National Monument Existing Boundary
