I've tried to give you a day or two to recover from the June 10<sup>th</sup> deadline for Bears Ears. I'm sure you could use more. But we're wondering how we can best help you help us. We are at your disposal and would be grateful for the opportunity of having detailed discussions regarding objects, protections and minimum areas for the Grand Staircase-Escalante National Monument.

Please give me a call, email or text when you have some time to talk. We want to get you the information you need.

I do have one immediate request. The Utah State Legislature "directed" us to consult with BLM regarding the appropriate Monument size and boundaries. GSENM leadership is hesitant to do any talking. Is there any way to encourage them to share what they have identified as distinct objects protected by the

GSENM Proclamation. Specifically, we are interested in historic landmarks, historic and prehistoric structures and objects of historic or scientific interest that are monument worthy.

We know what we think, but could use some help verifying from the BLM

I apologize if it is too soon to bug you. I'm also interested in your perception of Cabo San Lucas. I look forward to hearing from you.
