I was asked to get you some info on minerals in the GSENM. I can't put my hands on a mineral report (folks in Kanab can't either) so we pulled some readily available info together.

Attached are some maps showing various minerals and O&G and a page with some coal data.

The 39 oil and gas leases suspended in the monument are all under applications associated with the Combined Hydrocarbon Lease conversions dating back to the mid 1980's.
