Your name was suggested by leadership as someone that I should reach out to that would be really good at helping with on this team we are trying to put together. The DOI is asking the BLM to set up a 6-8 person review team as part of the National Monument review to review the public comments that come in. They are looking for people with a general awareness of public land management issues who are also fast readers and can make quick decisions. They do not need to be subject matter experts on monuments although that does not disqualify them from this phase of the review. Team members can be remote and will work from their desks or telework, with a username and password to access the system. The initial focus will be on Bears Ears. It is anticipated the workload would be 2-3 days per week for 3-5 weeks, but could vary if the correspondence review process goes slower than anticipated, or if a substantially larger number of comments are received than anticipated.

As part of the National Monument review public comments the BLM is being asked to set up a 6 8 person review team by COB Wednesday the 24th. We have one person from WO 200 and WO 400 and need four additional people.

They are looking for people with a general awareness of public land management issues who are also fast readers and can make quick decisions.
