WASHINGTON – Through a notice published in the Federal Register on Thursday, June 15, 2017, the Bureau of Land Management (BLM) postponed the compliance dates for certain oil and gas regulations contained in the 2016 final rule entitled, "Waste Prevention, Production Subject to Royalties, and Resource Conservation" (2016 final rule). "In addition to issuing the immediate postponement of upcoming deadlines, DOI is working on proposed rules that would remove unnecessary burdens imposed by the existing rule and extend current compliance deadlines while these revisions are being developed," said Vincent DeVito, Counselor for Energy Policy to the Secretary of the Interior. "Extending the filing deadlines in the court proceedings will enable the agency to focus on making these changes and would benefit all parties by avoiding needless litigation."

Distribution Plan Available for FY 2017 Funding for Bureau of Reclamation

A majority of funding will be available for water conservation and delivery, Western drought response and rural water projects

WASHINGTON – Bureau of Reclamation Acting Commissioner Alan Mikkelsen today released the spending plan for \$112.3 million of the total \$179.3 million provided to Reclamation in the Consolidated Appropriations Act of 2017, which provided funds in six categories within Water and Related Resources for Reclamation activities. The funds will go toward water conservation and delivery, Western drought response, rural water projects, and other important projects.

"A sustainable water supply is important to everyone throughout the West," Acting Commissioner Mikkelsen said. "The funding in this spending plan will assist infrastructure improvements that supports Reclamation's mission of delivering water and generating power in the Western United States."

The funding of \$112.3 million is divided among six categories:

- water conservation and delivery (\$12.0 million);
- Western drought response (\$40.0 million);
- rural water (\$46.5 million);
- environmental restoration and compliance (\$7.0 million);
- fish passage and fish screens (\$5.0 million); and
- facility operations, maintenance, and rehabilitation (\$1.8 million).

As of 5:00 a.m. EDT, a disturbance characterized as having potential to become Tropical Cyclone Three was located approximately 305 miles south-southwest of the mouth of the Mississippi River. The disturbance is expected to be near the Louisiana coast by Wednesday night, with some slight strengthening possible before the system reaches the coast. A Tropical Storm Warning is in effect from Cameron, Louisiana to the mouth of the Pearl River, accompanied by a Tropical Storm Watch from west of Cameron, Louisiana to High Island, Texas. Tropical storm conditions are expected within the warning area this afternoon. The greatest threat is inundation of 1 to 3 feet along the coast in the Tropical Storm Warning area. Total rain accumulations of 4 to 8 inches with isolated maximum amounts of 10 inches are expected over southeastern Louisiana, southern Mississippi, southern Alabama, and the Florida Panhandle through Thursday morning. Rainfall amounts of 2 to 4 inches with isolated maximum amounts of 6 inches can be expected farther west, from southwestern Louisiana to southeastern Texas, through Thursday morning.

Interior Head Says Public Lands Can Make U.S. A ‘Dominant’ Oil Power.

Reuters (6/19, Volcovici) reports Interior Secretary Ryan Zinke said that drilling and mining on protected federal lands could help the US become dominant as a global energy force. He said, “There is a social cost of not having jobs. ... Energy dominance gives us the ability to supply our allies with energy, as well as to leverage our aggressors, or in some cases our enemies, like Iran.” Last week, Zinke recommended that President Trump reduce the size of the Bears Ears National Monument, the first recommendation in a series of reviews of the monuments in the US. While the Interior Secretary said the US government should find solutions to address climate change, jobs are the top priority. He said, “If you don’t have an economy you can’t afford to put in the environmental protections you need.”

Federal, Range Leaders Discuss Proposed Mining Ban Near Boundary Waters.

WDIO-TV Duluth, MN (6/19) reports that Rep. Rick Nolan and “several other elected officials were in Mountain Iron Monday to discuss the proposed mining ban” near the Boundary Waters. According to the article, “the group of elected officials toured UTAC in Eveleth before having a

meeting on the proposed ban at the RAMS office in Mountain Iron.” Nolan “called the meeting a successful discussion on the ban, and controversial topic of having a clean environment and growing mining economy.”
