Hi David,

These thoughts are entirely my own, but having read comments on other public notices I have a few suggestions.

1. Based on what has already been reported the number of public comments will number in the tens of thousands, so I would recommend that the words "fossil" and "paleontology" be provided at the top of each comment. That way it will be easier to index or track the nature of comments.
2. Give a title to each major thought or comment (such as area of discussion or individual monuments). That way it will be clear that multiple comments are part of a single submission.
3. Have a concise one sentence introduction to each comment before expanding on narrative and explanation.
4. Long introductions and salutations are not necessary; give a one sentence introduction (also using the words "fossil" and "paleontology") and then get directly to the comments.
5. If you are representing a community (i.e. SVP), state in the introduction the mission of your organization and how many people your comments represent.

Hi David,

DOI has a press release that should be the source of Secretary Zinke's comments (1). In it he states that the public comment period for Bears Ears National Monument is extended to July 10, the same deadline for commenting on the rest of Executive Order 13792, *Review of Designations under the Antiquities Act*, April 26, 2017 (2). This is important because there will be a final report later this year that makes specific recommendations for the national monuments in question, including Bears Ears National Monument (3). It's not attached to the DOI press release, but I found a copy of the interim report linked to multiple news reports (4).

Dear Scott,
Based on Secretary Zinke's statements to the press today, he clearly ignored SVP's comments about the scientific importance of the fossil bearing units in Bears Ears National Monument when he formulated his recommendation to the President.

Zinke is quoted in the Washington Post as saying, "If you look at the Bears Ears as a whole, there's a lot more drop-dead gorgeous land than there are historic,

prehistoric objects. These items and objects can be identified, segregated and reasonably separated.”

As we documented in our comments (and as demonstrated by confidential DOI data), virtually the entire area of Bears Ears protects important vertebrate fossil localities.

Can you recommend a process by which DOI’s statement that there is more land than there are prehistoric objects be corrected?
