#### UPDATE ON LEGISLATION OF INTEREST

##### **Congress Passes Omnibus Spending Package for Fiscal Year 2017**

H.R. 244, the Consolidated Appropriations Act for fiscal year (FY) 2017 passed the House and Senate by large bipartisan majorities on Wednesday May 3 and Thursday May 4, respectively (309-118 in the House and 79-18 in the Senate). The bill has been sent to the President for his signature. The omnibus contains a net \$11 million increase from FY 2016 enacted levels for the U.S. Fish and Wildlife Service.

#### HEARINGS AND MARKUPS OF INTEREST

##### **House Subcommittee Discusses Intent and Scope of the Antiquities Act**

On Tuesday, May 2, the House Natural Resources Subcommittee on Federal Lands held an oversight hearing titled, “Examining the Consequences of Executive Branch Overreach of the Antiquities Act.” Subcommittee members spoke to many issues of interest to the Service, including:

- **Chairman Tom McClintock (R-CA-4), Rep. Steve Pearce (R-NM-2), and Rep. Bruce**

**Westerman (R-AR-4)** discussed the limited original intent of the Antiquities Act to protect archaeological artifacts and memorialize important events.

- **Rep. Doug LaMalfa (R-CA-1)** suggested concerns with the Antiquities Act hinge on the size of recent designations.
- **Ranking Member Colleen Hanabusa (D-HI-1), Rep. Niki Tsongas (D-MA-5), and Rep. Jared Huffman (D-CA-2)** discussed the broad, bipartisan support among past presidents and the public for monument designations.
- **Chairman McClintock, Full Committee Chairman Rob Bishop (R-UT-1), Rep. Tsongas, and Rep. Raúl Labrador (R-ID-1)** discussed the role of input from states, tribes, and local communities prior to monument designations under the Antiquities Act. **Rep. Pearce** and **Rep. LaMalfa** suggested that executive action leads to monument designations that are not supported by local communities.
- **Chairman McClintock, Rep. Westerman, Chairman Bishop, Rep. Jimmy Panetta (D-CA-20), and Rep. Glenn Thompson (R-PA-5)** asked about the economic impacts of monument designations. **Rep. Tsongas, Rep. Grijalva, and Rep. Huffman** suggested that monument designations economically benefit local economies with increased tourism.
- **Rep. Westerman, Rep. Thompson, and Chairman Bishop** asked about the limitations monument designations place on managing for wildfire risk.
- **Rep. Paul Gosar (R-AZ-4), Rep. LaMalfa, and Chairman McClintock** discussed the impacts to grazing and water rights, road maintenance, and recreational access from monument designations. **Rep. Don Beyer (D-VA-8)** asked whether opponents of monument designations were worried about too little access for recreation or the damage that could result from too much access.
- **Rep. Norma Torres (D-CA-35)** asked about the impact of rescinding monument designations on the Department of Interior's tribal trust responsibilities.
- **Chairman McClintock and Rep. Pearce** proposed potential reforms to the Antiquities Act, including limiting the number of acres allowed to be set aside and requiring state and local governments to be part of the decision process. **Rep. Labrador** shared plans to reintroduce legislation that would require states to approve monument designations.
- **Ranking Member Grijalva and Rep. Beyer** asked about the impacts of climate change on national monuments.

### **Senate Committee Discusses Environmental Review and Infrastructure**

On Wednesday, May 3, the Senate Environment and Public Works Committee held an oversight hearing titled, "Infrastructure Project Streamlining and Efficiency: Achieving Faster, Better, and Cheaper Results." Committee members spoke to many issues of interest to the Service, including:

- **Senator Dan Sullivan (R-AK)** discussed legislation he plans to introduce that would change how environmental reviews occur under the National Environmental Policy Act.
- **Senator James Inhofe (R-OK)** discussed streamlining review and permitting for

construction projects.

- **Ranking Member Tom Carper (D-DE)** urged members of the committee to focus on ensuring implementation of existing legislation passed in previous Congresses (such as the Moving Ahead for Progress in the 21st Century (MAP-21) Act and the Fixing America's Surface Transportation (FAST) Act) before proposing additional reforms. Carper also discussed how additional delays in environmental reviews could result from funding cuts to federal agencies.
