I started answering this yesterday and failed to send it. I noticed in my drafts folder this morning. Sorry.

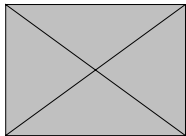

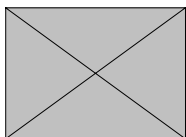
