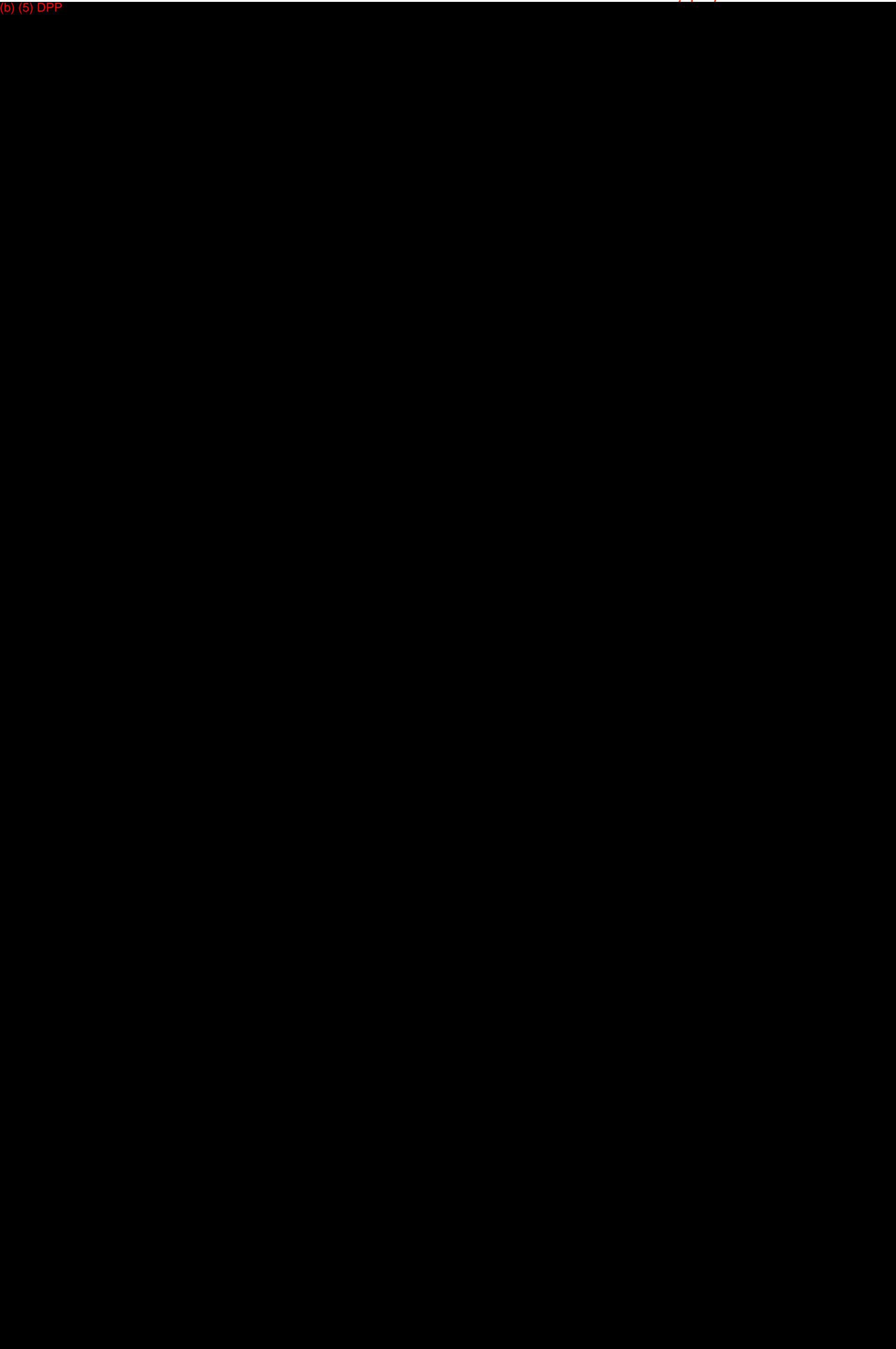





Bears Ears National Monument Boundary Modification
















Grand Staircase-Escalante National Monument Boundary Modification

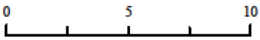
