Commercial Special Recreation Permits are authorizations that enable private businesses to conduct commercial recreational activities while protecting public lands' objects and values, and returning a fair market value to the American taxpayer. GSENM permitting program prioritizes the timely review of permit applications, and proactively works with each applicant to ensure a successful permit application. Currently the GSENM has approximately 120 Special Recreation Permit holders, of which approximately 40 percent are local businesses; 40 percent are regional businesses; and 20 percent are national businesses. Primary commercial recreational activities include guided hiking, backpacking, photography, hunting, education, and camping services. These commercial activities occur throughout the GSENM.
