As I understand it, the NOI is at the WO/DOI level pending finalization of language for the Federal Register Notice. We have not been asked to provide briefing materials, as the NOI is expected to be fast-tracked. We do need a comprehensive comm plan for the roll-out of the NOI, which could happen very soon.
