Planned Release Today: **USGS: In Next Decades, Frequency of Coastal Flooding Will**

Double Globally

The frequency and severity of coastal flooding throughout the world will increase rapidly and eventually double in frequency over the coming decades even with only moderate amounts of sea level rise, according to a new study released today in “Nature Scientific Reports.” This increase in flooding will be greatest and most damaging in tropical regions, impairing the economies of coastal cities and the habitability of low-lying Pacific island nations. Many of the world's largest populated low-lying deltas (such as the Ganges, Indus, Yangtze, Mekong and Irrawaddy Rivers), also fall in or near this affected tropical region.

Incident Management Team with 1050 (+79) personnel, including 179 (+25) DOI personnel. There are 320 (-480) residences and 7 (no change) commercial structures threatened. The containment date is November 1.

The Crown Mountain Fire, which began on May 14 within the Big Bend National Park in Texas, has burned 944 (-97) acres. The fire is 89-percent (+9) contained and managed by a Type-3 Incident Management Team with 81 (-81) personnel, including 16 (-20) DOI personnel. Demobilization and transition to a Big Bend National Park Type-4 IMT is ongoing. The containment date is May 22.

Media of Interest

Bernhardt Faces Opposition As Nominee For Top Interior Spot.

The Washington Examiner (5/17) reports that, in “an eleventh-hour push,” more than 100 environmental groups sent a letter to all senators calling for them to not support the confirmation of David Bernhardt as Interior Department deputy secretary. The groups argue that “Bernhardt’s representation of oil, coal and mining companies during his career in private legal practice as a major conflict of interest that will jeopardize the nation’s federal lands.” In the letter, the groups argue Bernhardt “should not seek, accept or be granted any exemptions from issues that he may have a conflict.” The Hill (5/17, Henry) predicts “a contentious confirmation hearing,” with opponents “gearing up to scrutinize his professional history and the role he intends to play in a Trump Interior Department that had already ruffled feathers among greens and conservationists.” Critics say that Bernhardt’s lobbying makes him a “walking conflict of interest.”

Zinke: National Bison Range To Remain Under FWS Management.

The Missoulian (MT) (5/17, Chaney) reports Interior Secretary confirmed his intention to keep the National Bison Range under US Fish and Wildlife Service management. FWS was “on track to transfer Bison Range management to” the Confederated Salish and Kootenai Tribes (CSKT) “until the end of President Barack Obama’s administration.” Zinke said in a Wednesday press release, “As secretary, my job is to look 100 years forward at all of Interior’s resources. I recognize the Bison Range is a critical part of our past, present and future, which is why I have changed course.” Zinke announced April 12 his intention to revisit the transfer plan “and restart the Bison Ridge’s comprehensive conservation plan,” and Wednesday’s announcement “expanded on that.”

Zinke: No Decisions Made On National Monuments.

The Lake Powell (AZ) Chronicle (5/17, Law) reports Interior Secretary Ryan Zinke was in Kanab, Arizona, last Wednesday after touring portions of the Grand Staircase-Escalante National Monument with Kane and Garfield county commissioners. Zinke met with reporters in Kanab and emphasize that neither the Trump Administration nor the department had reached a conclusion on the possibility of rescinding or shrinking 27 of America’s national monuments. He told reporters, “These are absolutely places that need to be protected, and that is our ultimate goal, to make sure the land is managed well.” Zinke added, “Everyone wants to protect their culture and traditions. There are a lot of things we can do better.” According to the article, Zinke “emphasized that he and the Department of the Interior are considering input from all parties involved from local governments.”

Washington Monument To Display Plaque From Ireland.

The AP (5/18) reports the National Park Service on Thursday “will accept a plaque from the people of Ireland that will be hung in the staircase of the monument.” The plaque “highlights the connection between the 2016 centennials of the park service and Ireland’s Easter Rising.” The monument’s stairwell “has scores of commemorative stones, most of which were received in the mid-19th century,” and the NPS says news donations are accepted “only in very rare circumstances.”

Ex-BLM Head Tells US House Committee National Monuments Hurt Local Economies.

The Lake Powell Life (5/17) reports former BLM head Kathleen Clarke appeared before a US House committee and “blasted national monuments for harming local economies and communities’ way of life.” She told the committee, “Monuments have had significant and negative impacts on the traditional uses of these lands and on the lives and livelihoods of local populations.” She added, “Landscapes don’t disappear, but jobs do.” The article mentions her position “contradicts the findings of two recent studies into the effects of monument creation.”

BLM Looking For Ways To Speed Up Application Process.

Fuel Fix (TX) (5/17, Osborne) reports that a drilling application backlog is hampering new oil and gas drilling on federal lands, as more than 3,000 applications for drilling permits are awaiting review at the Bureau of Land Management, according to E&E News. Acting Director Mike Nedd said the agency is working on several strategies to speed up the application process. He said, “It may be a strike team. It may be shifting the workload to a different office.” Neal Kirby, spokesman for the Independent Petroleum Association of America, said, “Every day that goes by while independent producers — companies with an average of 12 employees — wait for their permits to be approved means more money out of their own pockets.”

SCOTUS Denies Challenge To New York Land Trust Decision.

The Rome (NY) Sentinel (5/17) reports the US Supreme Court on Monday denied a petition from a group of plaintiffs challenging “a New York federal judge’s March 2015 ruling that Interior had reasonably decided to take thousands of acres in Oneida and Madison counties, including the Turning Stone Resort Casino in Verona and the Oneidas’ 32 acres of reservation land in Madison County, into trust for the Oneidas.” Interior placed the land into a trust “following the 2013 agreement with the state, Oneidas, and Oneida and Madison counties that settled trust land and tax issues.”

The Lake Powell Life (5/17) reports former BLM head Kathleen Clarke appeared before a US House committee and “blasted national monuments for harming local economies and communities’ way of life.” She told the committee, “Monuments have had significant and negative impacts on the traditional uses of these lands and on the lives and livelihoods of local populations.” She added, “Landscapes don’t disappear, but jobs do.” The article mentions her position “contradicts the findings of two recent studies into the effects of monument creation.”

BLM Looking For Ways To Speed Up Application Process.

Fuel Fix (TX) (5/17, Osborne) reports that a drilling application backlog is hampering new oil and gas drilling on federal lands, as more than 3,000 applications for drilling permits are awaiting review at the Bureau of Land Management, according to E&E News. Acting Director Mike Nedd said the agency is working on several strategies to speed up the application process. He said, “It may be a strike team. It may be shifting the workload to a different office.” Neal Kirby, spokesman for the Independent Petroleum Association of America, said, “Every day that goes by while independent producers — companies with an average of 12 employees — wait for their permits to be approved means more money out of their own pockets.”

SCOTUS Denies Challenge To New York Land Trust Decision.

The Rome (NY) Sentinel (5/17) reports the US Supreme Court on Monday denied a petition from a group of plaintiffs challenging “a New York federal judge’s March 2015 ruling that Interior had reasonably decided to take thousands of acres in Oneida and Madison counties, including the Turning Stone Resort Casino in Verona and the Oneidas’ 32 acres of reservation land in Madison County, into trust for the Oneidas.” Interior placed the land into a trust “following the 2013 agreement with the state, Oneidas, and Oneida and Madison counties that settled trust land and tax issues.”
