## **Emergency Management**

In Arizona, the Freeze 2 Fire on the San Carlos Reservation (BIA) has burned 2,832 (+3) acres and is 55 (+20) percent contained. The fire is managed by a Type-2 Incident Management Team with 330 (-14) personnel assigned, including 129 (+6) DOI personnel. One responder injury has been reported. The containment date is June 19.

Also in Arizona, the Lizard Fire has burned 15,142 (+11) acres and is 64 (+24) percent contained. The fire is managed by a Type-1 IMT with 638 (+37) personnel assigned, 144 (+1) of which are DOI personnel. There are 18 (-37) structures threatened and 50 (no change) evacuations as of this reporting period. The containment date has been set for July 7. The Lizard Fire is a U.S. Forest Service (USFS) fire burning mostly on USFS lands, but the

perimeter also includes a Bureau of Land Management (BLM) parcel in the northern portion of the fire.

The SEIS will also supplement the analysis of public water reserves.

#### **Zinke Says Government Is Failing Tribes, Deflects Budget Concerns.**

Law360 (6/13, Westney) reports that Interior Secretary Ryan Zinke “told a National Congress of American Indians conference Tuesday that federal programs serving tribes aren’t working, as NCAI officials and tribal leaders raised concerns about funding cuts to such programs in the Trump administration’s proposed budget.”

#### **Interior Secretary Ryan Zinke Makes Stop In Hooksett.**

New Hampshire Public Radio (6/13, Greene) reports that Interior Secretary Ryan Zinke “stopped at the Bass Pro Shop in Hooksett Tuesday afternoon, appearing with Governor Chris Sununu and State Fish and Game Executive Director Glenn Normandeau.” At the store, Zinke “signed a ceremonial \$1.1 billion check for fish and wildlife conservation programs.”

#### **US Interior Chief To Visit Maine Monument Under Review.**

The AP (6/14, Whittle) reports that Interior Secretary Ryan Zinke is “heading to Maine on Wednesday to see Katahdin Woods and Waters National Monument as part of a tour of national monuments that are under review.” Zinke is “scheduled to spend the day driving, hiking and canoeing through the monument grounds and waters.”

#### **Deciphering Protections Inside Bears Ears Monument Designation.**

The Deseret (UT) News (6/13, O'Donoghue) reports that “when Interior Secretary Ryan Zinke announced a preliminary recommendation that contemplates shrinking the boundaries of the Bears Ears National Monument, one of the key points he emphasized is that some of the land is already subject to special management restrictions.” Zinke’s interim report “notes there are 11 wilderness study areas inside the monument that comprise 381,000 acres and are managed by the Bureau of Land Management.” According to the article, “the lands have to be in the same or better condition than they were 41 years ago to ensure Congress has the ability to invoke permanent wilderness protection.” The article notes “that year is significant, 1976, when Congress passed the Federal Lands Policy Management Act that set up the majority of Utah’s wilderness study areas — vast amounts of land that have remained in limbo since then.”

#### **California’s Senators Ask Residents To Tell The Federal Government To Stay Away From The State’s National Monuments.**

The Los Angeles Times (6/13, Wire) reports that “California’s senators are trying to prevent changes to six national monuments in the Golden State, and they’re asking Californians to help by sending comments to the Interior Department.” In a letter to Interior Secretary Ryan Zinke, Sens. Dianne Feinstein and Kamala Harris wrote, “On behalf of all Californians, we urge that these national monument designations are preserved with their present boundaries, to ensure these special places remain for generations to come.”

#### **BLM Oil And Gas Lease Auction Brings In Over \$720,000.**

The Fairfield (MT) Sun Times (6/13) reports that “bids on oil and gas leases in northern and southeastern Montana brought in \$720,843 in an online auction held June 13, by the Bureau of Land Management.” The auction “included 156 parcels encompassing approximately 69,000 acres of federal minerals in Big Horn, Carter, Custer, Fallon, Garfield, Powder River and Rosebud Counties were offered at auction.”

#### **Interior Releases \$7.8M For American Samoa.**

Marianas Variety (6/14) reports that the Office of Insular Affairs has “released \$7.8 million remaining in grant assistance for fiscal year 2017 to the American Samoa Government through the Office of Insular Affairs’ Operations Grant Program.” Interior Acting Assistant Secretary for Insular Areas Nikolao Pula said, “These funds are critical for government operations in the territory of American Samoa. We are pleased to transmit the remaining funds on behalf of the administration.”
