SECRETARY ZINKE SIGNS SECRETARIAL ORDER TO SUPPORT SPORTSMEN & ENHANCE WILDLIFE CONSERVATION

Order seeks to expand access on public and private lands and to promote hunting and fishing among youth, veterans, and minority communities

WASHINGTON – Today, U.S. Secretary of the Interior Ryan Zinke signed Secretarial Order 3356,

which will support and expand hunting and fishing, enhance conservation stewardship, improve wildlife management, and increase outdoor recreation opportunities for all Americans. Secretarial Order 3356 is an extension of Secretarial Order 3347, issued on Zinke's first day, March 2, 2017. That order identified a slate of actions for the restoration of the American sportsmen conservation ethic, which was established by President Theodore Roosevelt.

The new order comes days after the U.S. Fish and Wildlife Service announced a survey that found there are 2.2 million fewer hunters in America now than in 2011. The order seeks to improve wildlife management and conservation, increase access to public lands for hunting, shooting, and fishing, and puts a new and a greater emphasis on recruiting and retaining new sportsmen conservationists, with a focus on engaging youths, veterans, minorities, and other communities that traditionally have low participation in outdoor recreation activities.

Mr. Bernhardt was not involved in the Mohave Trail Monument Review. The Deputy Secretary, after close coordination with the career ethics experts within the Office of Ethics, has fully complied with his obligations under the Ethics pledge. Mr. Bernhardt has agreed to recuse himself from particular matters involving specific parties. He has committed to ensuring that he is setting the highest ethical standards for his office.

- This week the Secretary is in Washington, D.C., until Sept. 20, where he will travel to Springfield, MO, to participate in the ribbon cutting and the opening of the “Wonders of Wildlife National Museum and Aquarium.”
- This week we are working with our federal, state, and Tribal partners to support the WH and FEMA with the Hurricane recovery and wildfire response. The NPS Director is in the USVI to oversee response efforts.

- September 16: Department-level Release: Duck Stamp winners announced.
- TBD: Assistant Secretary for Insular Affairs Doug Domenech was confirmed by the Senate the evening of September 13. We will issue a statement and photo of his swearing-in asap.

National Park Service

- September TBD: Local NPS Release: NPS Pacific West Region will announce the new superintendent of Redwood National and State Parks.
- September TBD: Local NPS Release: NPS will issue a news release regarding the independent review panel findings that Golden Gate National Recreation Area dog rule process was unaffected by inappropriate personal email use.
- September 17: Antietam National Battlefield will commemorate the 150th anniversary of Antietam National Cemetery. The ceremony will begin at noon and include speeches by historian Gary Gallagher, U.S.S. Antietam Captain George Kessler, and Maryland Lieutenant Governor Boyd Rutherford. Following the ceremony, the public will be invited to participate in a reading of the names of those interred in the cemetery and the placing of flags at each grave site.

U.S. Fish and Wildlife Service

- September 14: Local FWS Release: Release announcing the final listing determination for the pearl darter as threatened. FWS is required to publish the determination in the Federal Register by September 21.
- September 14: Local FWS Release: By September 14, FWS will send to the Federal Register the final rule to list the Sonoyta mud turtle as an endangered species. Sonoyta mud turtle was designated a candidate in 1997 and we were petitioned to list the species in 2004 (in a 225 organism mega-petition). The turtle occurs in the U.S. in only one population at Organ Pipe Cactus National Monument in southern Arizona, and four populations in northern Sonora Mexico. These five remaining populations occupy only about 8-20 percent of the turtle's historical range.
- September 15: Local FWS Release: FWS Region 2 will announce this voluntary conservation agreement to conserve the Texas hornshell mussel.
- September 19: Local FWS Release: FWS is required by settlement agreement to submit the endangered finding for the ʻiʻiwi to the Federal Register by September 20. Outreach is planned to Hawaiian media and to national conservation and bird-centric media.
- September TBD: Public comment period opening for voluntary wildlife conservation opportunity designed with Montana ranchers, regulatory certainty for the next 20 years through a Programmatic Candidate Conservation Agreement with Assurances (CCAA). Participants can voluntarily take steps to conserve the Sprague's pipit, McCown's longspur, chestnut-collared longspur, Baird's sparrow, and greater sage-grouse on their property while conducting their general business operations.

Bureau of Land Management

- Week of September 18: Local BLM Release: BLM-AZ will announce the acquisition of the 600-acre ET Ranch in Southeastern Arizona, through a shared conservation partnership with the Trust for Public Land and Arizona Game and Fish Department. The acquisition will open access for hunters, hikers, and backpackers to 32,600 acres of Federal wilderness area for the first time and is supported by 20 Arizona hunting and sporting groups.
- September 18: The public comment period closes on the BLM-NV December 2017 Oil and Gas Lease Sale Preliminary Environmental Assessment. A competitive oil and gas lease sale will be held December 12. The BLM received requests to lease 208 nominated parcels of public land, totaling 388,960 acres. The parcels are located in White Pine, Nye County, and Lincoln County. There is no estimate on the number of bidders at this time.
- September 19: BLM-WY Buffalo Field Office will meet with landowners from around the Pumpkin Buttes Traditional Cultural Property to discuss concerns with a proposed Programmatic Agreement that would streamline and define that tribal consultation about federal projects within three miles of the area would take place. The meeting will be staffed by local BLM management and subject matter experts on oil and gas development and cultural resources from the Buffalo Field Office. The public and media will be invited.
- September 21: National BLM Release: BLM-Eastern States will hold an online oil and gas lease sale for three parcels in Monroe County, OH, totaling 141.56 acres, and 3 parcels in Catahoula and Bienville Parishes, LA, totaling 50.15 acres. The sale in Ohio is expected to be controversial. Bidding is not expected to be robust.
- September 21: National BLM Release: BLM-WY will hold an online oil and gas lease sale for 141 parcels totaling 118,055.54 acres in Niobrara, Weston, Goshen, Crook, Converse, Campbell, Johnson, Fremont, Big Horn, Washakie, Weston, and Sheridan Counties, WY. The sale is not

expected to be controversial. Bidding is not expected to be robust.

U.S. Geological Survey

Emergency Management (new)

As operations for Hurricane Harvey and Irma have begun to transition from response to long term recovery, the Interior Operations Center (IOC) will reduce its operational status to Level 3 (Enhanced Operations) effective September 15, 2017, at 8:00 a.m. EDT.

Support updates to the interagency Hurricane Irma Response are as follows:

DOI currently has 190 personnel supporting 10 FEMA Mission Assignments (MA) in response to Hurricane Irma.

The Bureau of Indian Affairs (BIA) officially received a FEMA MA under Emergency Support Function (ESF) #5 (Information and Planning) to deploy one (1) BIA Liaison Officer (LNO) to Florida to help coordinate with the Region 4 Tribal Liaison, the Seminole Tribe, and other affected tribes in the state during response and recovery efforts. This LNO is expected to arrive in Florida today. The MA also includes support for BIA's Tribal Assistance Coordination Group (TAC-G) which is the first time FEMA has recognized the TAC-G's role in tribal response activities.

In support of ESF #5 (Information and Planning), U.S. Geological Survey (USGS) had one person in Puerto Rico flagging high water marks (HWMs) on September 13. Additionally, USGS had 26 personnel in Florida and 10 in Georgia retrieving storm surge sensors and analyzing data. A total of 42 surge sensors were retrieved between the two states. Two additional personnel were analyzing previously gathered data from sensors in South Carolina, where all 66 surge sensors have successfully been retrieved.

In support of ESF #13, Public Safety and Security, DOI Irma Quick Response Teams (QRTs) 1, 4, and 6 relocated to Orlando, Florida, yesterday, pending their assignment. As of September 13, Moody Air Force Base is no longer being utilized as an ESF #13 staging area. DOI IRMA QRTs 1, 4, and 6 will support ESF #8 (Public Health and Medical Services) and ESF #9 (Search and Rescue) missions.

With respect to internal bureau and office-specific Irma activities:

The National Park Service (NPS) has 100-percent accountability of their employees. The current priorities are restoring services and access to the parks, debris removal, and providing support to employees who were impacted by Hurricane Irma. The NPS is tracking 140 personnel who are supporting Hurricane Irma response and recovery efforts, and the NPS Emergency Incident Coordination Center (EICC) remains at enhanced staffing. The NPS Eastern Incident Management Team (EIMT) has established operations in a local hotel until power is restored and they can permanently relocate to the Everglades National Park. The EIMT is coordinating saw teams and

assessment teams, including a team scheduled to visit the U.S. Virgin Islands. Detailed reports from parks most severely affected are contained within the attached DOI Emergency Management Daily Situation Report.

The U.S. Fish and Wildlife Service (USFWS) reports 55 (-1) stations closed in the Service's Southeast Region (Region 4) due to Hurricane Irma. Task forces from the Incident Management Team are finishing up at Okefenokee National Wildlife Refuge (NWR) and Panther NWR. They are scheduled to move to Welaka National Fish Hatchery and the Florida Keys NWR Complex upon completion of their current mission. The Special Operations Response Team (SORT) has four additional officers on the way to Florida to provide additional Refuge security. The SORT will also be conducting a mission on Key West to search for an employee family member that is still missing. The USFWS Office of Law Enforcement has a fuel truck stationed in Tallahassee, Florida, with two agents standing by to provide supplies and relief to other employees in the impact zone. The Groveland, Vero Beach, Tampa Port, Tallahassee, and Jacksonville Offices are open for business. Detailed reports from refuges most severely affected are contained within the attached DOI Emergency Management Daily Situation Report.

BIA reports that the FEMA Region 4 Tribal Liaison and a FEMA team are on site with the Seminole Tribe, and are assisting with submitting resource requests and completing damage assessments. The Seminole Tribe of Florida has 4 shelters open, with a total population estimated at 48 (-37). Seventy-five Federal Law Enforcement Officers (FLEOs) arrived at the Seminole Tribe Emergency Operations Center on September 13. These personnel will be deployed to the Big Cypress, Brighton, Immokalee, and Hollywood Reservations. The Seminole Tribe has requested a general practitioner doctor from Indian Health Services (IHS) to support the Brighton Reservation clinic. While cellular companies are working to repair cell towers, the Seminole Tribe continues to have problems with receiving gas, diesel, and propane. The previously requested pharmacy shipment from IHS arrived as scheduled.

All U.S. Geological Survey (USGS) personnel are accounted for. In Puerto Rico, five USGS personnel were in the field yesterday making discharge measurements, repairing gages, and flagging additional measurements. In Florida, 52 personnel were assessing damage to gages, repairing gages, and making discharge measurements. Personnel from the USGS Caribbean-Florida Water Science Center have developed preliminary coastal change forecasts for the Florida Atlantic coast based on potential impacts from Hurricane Jose, and are coordinating results with the National Oceanic Atmospheric Administration, the U.S. Army Corps of Engineers, and other partners.

Support updates to the interagency Hurricane Harvey Response are as follows:

DOI currently has 60 personnel supporting 5 FEMA MAs in response to Hurricane Harvey.

In support of ESF #4 (Firefighting), USFWS has 21 personnel deployed to Beaumont, Texas.

In support of ESF #5 (Information and Planning), 26 USGS personnel from Texas, Arizona, Oklahoma, New Mexico, and Nebraska were in the field yesterday flagging and surveying in Texas. A total of 839 (+77) locations have had HWMs flagged, with 376 (+24) locations surveyed.

Law Enforcement Updates:

On September 16, six known gatherings will take place in the District of Columbia. Four of these events will take place on or around the area of the National Mall, with one of them being a counter-demonstration. A fifth event is being scheduled for Lafayette Park that should have no impact on the others, and the sixth event, as of now, is occurring on the grounds of the United States Capitol, but may include a march to the White House. The groups include: Mother of All Rallies (MOAR); Juggalo March on Washington, DC; March to Protect American Democracy; Root out Racism; DC Means “Don’t Come” – MOAR Counter Demonstration and, Arms Wide Open (Childhood Cancer Awareness). Due to the large number of participants as well as road closures associated with planned marches, a large police presence is needed for safety purposes.

Wildland Fire Updates:

The Sprague Fire in Glacier National Park, MT (NPS), has burned 15,995 (+1,200) acres and is 60 (no change)-percent contained. The fire is managed by a Type-2 IMT with 169 (+2) personnel assigned, including 89 (+14) DOI personnel. There are 238 (no change) structures threatened, 48 (no change) commercial structures threatened, and 4 (no change) persons sheltered in place. The fire is causing significant economic impacts to park concessions, outfitters, and local residents. Full containment is expected on November 1.

Outside Media of Interest (new)

US Wildfire Costs Hit Record \$2.3 Billion; Season Isn’t Over.

The AP (9/14) reports that “the U.S. government says it has already spent a record \$2.3 billion fighting wildfires this year, and 64 major fires are still burning in 10 states.” The Forest Service “said Thursday it has spent more than \$2 billion, and the Interior Department says it has spent \$345 million.” The article notes that “the previous record for combined federal firefighting costs was \$2.1 billion in 2015.”

Herbert: Zinke Signaled Grand-Staircase Should Be Shrunk.

The AP (9/14, PRICE) reports that Utah Gov. Gary Herbert “said Thursday that Interior Secretary Ryan Zinke has signaled that he’s recommending President Donald Trump shrink Utah’s two-decade old Grand Staircase-Escalante National Monument.” Herbert “doesn’t specifically know what Zinke has recommended for the 1.9-million acre (7,700-square kilometer) area or Utah’s new Bears Ears National Monument, but the governor said at his monthly news conference, taped at KUED-TV Thursday, that Zinke felt former President Bill Clinton’s 1996 declaration of Grand Staircase-Escalante went too far.”

BLM: Wyoming Working To Fulfill Trump Energy Agenda.

The Wyoming Tribune Eagle (9/14, Funk) reports that “with a very different energy agenda in the administration of President Donald Trump than his predecessor, the Bureau of Land Management in Wyoming is ready to adapt to those changes,” according to Duane Spencer, BLM of Wyoming deputy state director for minerals and lands. Spencer “spoke Wednesday during the 2017 BLM Industry and Government Conference in Rawlins.” Spencer said, “We have been working very closely with our Washington (D.C.) office to bring them up to speed on what Wyoming is working on, what resources we offer, and that we believe BLM Wyoming is strategically positioned to deliver on what some of the administration’s priorities are – in particular, the goal of making America safe through energy independence and contributing to economic development and local economies.”

Protests Over BLM Timber Sale.

KOBI-TV Medford, OR (9/14, Jordan) reports that “an auction for logging rights to hundreds of acres of Bureau of Land Management property drew a crowd of protesters in Grants Pass.” The BLM “says the land needs logging to prevent fires.” But “protesters were concerned about the thinning of old growth trees.”

Deep-Sea Study To Begin Off Southeast Coast.

The Coastal Review (9/14) reports that “a team of scientists is set to launch in the coming weeks a four-and-a-half year study of deep-sea coral, canyon and gas-seep ecosystems in the mid- and south Atlantic.” The team will “travel aboard the National Oceanic and Atmospheric Administration’s ship Pisces to explore biological features and geological processes, such as corals and naturally occurring gas seeps and the organisms that inhabit them.” The Bureau of Ocean Energy Management, the U.S. Geological Survey and NOAA’s Office of Exploration and Research are “supporting the study intended to shed light on little-known natural resources of the deep ocean off the Southeast coast.”

U.S. And Mexico Set To Sign Landmark Colorado River Water-sharing Deal.

USA Today (9/14, James) reports that “the U.S. and Mexican governments are close to signing a landmark Colorado River deal that will establish rules for sharing water over the next decade and lay out cooperative efforts intended to head off severe shortages.” Officials have “scheduled a signing ceremony on Sept. 26 in Ciudad Juárez, officials at California water districts said this week.” They said “that formal event will be followed by a ceremonial signing in Santa Fe, N.M., on Sept. 27 attended by representatives from the states involved.”

Environmental Groups Challenge Use Of Waivers To Build At Border.

The San Diego Union-Tribune (9/14, Moran) reports, “A coalition of environmental groups on Thursday sued the Department of Homeland Security challenging the use of sweeping power under a federal law to ignore environmental laws in order to build walls, fences and roads on the border.” The lawsuit was filed in federal court in San Diego by Defenders of Wildlife, the Sierra Club, and the Animal Legal Defense Fund. The Union-Tribune says the lawsuit “targets a section of the REAL ID Act of 2005 which granted the Secretary of Homeland Security the power to waive complying with federal laws such as the Endangered Species Act, Clean Air Act in order to expedite border security building projects.” The lawsuit “contends that the use of the law was limited to a certain time period after it was passed by Congress, and was not meant to be a perpetual tool the government can use to avoid laws.” The AP (9/14) reports the lawsuit “largely mirrors a lawsuit filed by another advocacy group, the Center for Biological Diversity, but the three organizations each say they have hundreds of thousands of members, bringing more attention and resources to a legal fight over one of President Donald Trump’s key campaign pledges.”

Berkeley Gets Black Panther Tribute \$98K.

The Daily Caller (9/14, Krayden) reports that the National Park Service is “giving \$98,000 to commemorate a violent student protest group: the Black Panther Party.” The NPS is “offering money to UC Berkeley so that it might ‘honor the legacy’ of the ‘60s-era organization that preached a communist revolution and upheld black nationalism.”

Angry Mapp Chastises Community For Unreal Expectations.

The Virgin Islands Daily News (9/13) reports that Gov. Kenneth Mapp “led off his nightly press

conference on Wednesday with an angry condemnation directed at members of the community he said have unreal expectations about the recovery efforts in the wake of Hurricane Irma.” On Wednesday, Mapp “first acknowledged the death of WAPA lineman Jason Julius before launching into a diatribe about the community’s complaints about the progress of recovery efforts.”

SECRETARY ZINKE SIGNS SECRETARIAL ORDER TO SUPPORT SPORTSMEN & ENHANCE WILDLIFE CONSERVATION

Order seeks to expand access on public and private lands and to promote hunting and fishing among youth, veterans, and minority communities

WASHINGTON – Today, U.S. Secretary of the Interior Ryan Zinke signed Secretarial Order 3356, which will support and expand hunting and fishing, enhance conservation stewardship, improve wildlife management, and increase outdoor recreation opportunities for all Americans. Secretarial Order 3356 is an extension of Secretarial Order 3347, issued on Zinke's first day, March 2, 2017. That order identified a slate of actions for the restoration of the American sportsmen conservation ethic, which was established by President Theodore Roosevelt.

The new order comes days after the U.S. Fish and Wildlife Service announced a survey that found there are 2.2 million fewer hunters in America now than in 2011. The order seeks to improve wildlife management and conservation, increase access to public lands for hunting, shooting, and fishing, and puts a new and a greater emphasis on recruiting and retaining new sportsmen conservationists, with a

focus on engaging youths, veterans, minorities, and other communities that traditionally have low participation in outdoor recreation activities.

- September 19: BLM-WY Buffalo Field Office will meet with landowners from around the Pumpkin Buttes Traditional Cultural Property to discuss concerns with a proposed Programmatic Agreement that would streamline and define that tribal consultation about federal projects within three miles of the area would take place. The meeting will be staffed by local BLM management and subject matter experts on oil and gas development and cultural resources from the Buffalo Field Office. The public and media will be invited.

Emergency Management (new)

As operations for Hurricane Harvey and Irma have begun to transition from response to long term recovery, the Interior Operations Center (IOC) will reduce its operational status to Level 3 (Enhanced Operations) effective September 15, 2017, at 8:00 a.m. EDT.

Support updates to the interagency Hurricane Irma Response are as follows:

DOI currently has 190 personnel supporting 10 FEMA Mission Assignments (MA) in response to Hurricane Irma.

The Bureau of Indian Affairs (BIA) officially received a FEMA MA under Emergency Support Function (ESF) #5 (Information and Planning) to deploy one (1) BIA Liaison Officer (LNO) to Florida to help coordinate with the Region 4 Tribal Liaison, the Seminole Tribe, and other affected tribes in the state during response and recovery efforts. This LNO is expected to arrive in Florida today. The MA also

includes support for BIA's Tribal Assistance Coordination Group (TAC-G) which is the first time FEMA has recognized the TAC-G's role in tribal response activities.

In support of ESF #5 (Information and Planning), U.S. Geological Survey (USGS) had one person in Puerto Rico flagging high water marks (HWMs) on September 13. Additionally, USGS had 26 personnel in Florida and 10 in Georgia retrieving storm surge sensors and analyzing data. A total of 42 surge sensors were retrieved between the two states. Two additional personnel were analyzing previously gathered data from sensors in South Carolina, where all 66 surge sensors have successfully been retrieved.

In support of ESF #13, Public Safety and Security, DOI Irma Quick Response Teams (QRTs) 1, 4, and 6 relocated to Orlando, Florida, yesterday, pending their assignment. As of September 13, Moody Air Force Base is no longer being utilized as an ESF #13 staging area. DOI IRMA QRTs 1, 4, and 6 will support ESF #8 (Public Health and Medical Services) and ESF #9 (Search and Rescue) missions.

With respect to internal bureau and office-specific Irma activities:

The National Park Service (NPS) has 100-percent accountability of their employees. The current priorities are restoring services and access to the parks, debris removal, and providing support to employees who were impacted by Hurricane Irma. The NPS is tracking 140 personnel who are supporting Hurricane Irma response and recovery efforts, and the NPS Emergency Incident Coordination Center (EICC) remains at enhanced staffing. The NPS Eastern Incident Management Team (EIMT) has established operations in a local hotel until power is restored and they can permanently relocate to the Everglades National Park. The EIMT is coordinating saw teams and assessment teams, including a team scheduled to visit the U.S. Virgin Islands. Detailed reports from parks most severely affected are contained within the attached DOI Emergency Management Daily Situation Report.

The U.S. Fish and Wildlife Service (USFWS) reports 55 (-1) stations closed in the Service's Southeast Region (Region 4) due to Hurricane Irma. Task forces from the Incident Management Team are finishing up at Okefenokee National Wildlife Refuge (NWR) and Panther NWR. They are scheduled to move to Welaka National Fish Hatchery and the Florida Keys NWR Complex upon completion of their current mission. The Special Operations Response Team (SORT) has four additional officers on the way to Florida to provide additional Refuge security. The SORT will also be conducting a mission on Key West to search for an employee family member that is still missing. The USFWS Office of Law Enforcement has a fuel truck stationed in Tallahassee, Florida, with two agents standing by to provide supplies and relief to other employees in the impact zone. The Groveland, Vero Beach, Tampa Port, Tallahassee, and Jacksonville Offices are open for business. Detailed reports from refuges most severely affected are contained within the attached DOI Emergency Management Daily Situation Report.

BIA reports that the FEMA Region 4 Tribal Liaison and a FEMA team are on site with the Seminole Tribe, and are assisting with submitting resource requests and completing damage assessments. The Seminole Tribe of Florida has 4 shelters open, with a total population estimated at 48 (-37). Seventy-five Federal Law Enforcement Officers (FLEOs) arrived at the Seminole Tribe Emergency Operations Center on September 13. These personnel will be deployed to the Big Cypress, Brighton, Immokalee, and Hollywood Reservations. The Seminole Tribe has requested a general practitioner doctor from Indian Health Services (IHS) to support the Brighton Reservation clinic. While cellular companies are working to repair cell towers, the Seminole Tribe continues to have problems with receiving gas, diesel, and propane. The previously requested pharmacy shipment from IHS arrived as scheduled.

All U.S. Geological Survey (USGS) personnel are accounted for. In Puerto Rico, five USGS personnel were in the field yesterday making discharge measurements, repairing gages, and flagging additional measurements. In Florida, 52 personnel were assessing damage to gages, repairing gages, and making discharge measurements. Personnel from the USGS Caribbean-Florida Water Science Center have developed preliminary coastal change forecasts for the Florida Atlantic coast based on potential impacts from Hurricane Jose, and are coordinating results with the National Oceanic Atmospheric Administration, the U.S. Army Corps of Engineers, and other partners.

Support updates to the interagency Hurricane Harvey Response are as follows:

DOI currently has 60 personnel supporting 5 FEMA MAs in response to Hurricane Harvey.

In support of ESF #4 (Firefighting), USFWS has 21 personnel deployed to Beaumont, Texas.

In support of ESF #5 (Information and Planning), 26 USGS personnel from Texas, Arizona, Oklahoma, New Mexico, and Nebraska were in the field yesterday flagging and surveying in Texas. A total of 839 (+77) locations have had HWMs flagged, with 376 (+24) locations surveyed.

Law Enforcement Updates:

On September 16, six known gatherings will take place in the District of Columbia. Four of these events will take place on or around the area of the National Mall, with one of them being a counter-demonstration. A fifth event is being scheduled for Lafayette Park that should have no impact on the others, and the sixth event, as of now, is occurring on the grounds of the United States Capitol, but may include a march to the White House. The groups include: Mother of All Rallies (MOAR); Juggalo March on Washington, DC; March to Protect American Democracy; Root out Racism; DC Means “Don’t Come” – MOAR Counter Demonstration and, Arms Wide Open (Childhood Cancer Awareness). Due to the large number of participants as well as road closures associated with planned marches, a large police presence is needed for safety purposes.

Wildland Fire Updates:

The Sprague Fire in Glacier National Park, MT (NPS), has burned 15,995 (+1,200) acres and is 60 (no change)-percent contained. The fire is managed by a Type-2 IMT with 169 (+2) personnel assigned, including 89 (+14) DOI personnel. There are 238 (no change) structures threatened, 48 (no change) commercial structures threatened, and 4 (no change) persons sheltered in place. The fire is causing significant economic impacts to park concessions, outfitters, and local residents. Full containment is expected on November 1.

Outside Media of Interest (new)

US Wildfire Costs Hit Record \$2.3 Billion; Season Isn’t Over.

The AP (9/14) reports that “the U.S. government says it has already spent a record \$2.3 billion fighting wildfires this year, and 64 major fires are still burning in 10 states.” The Forest Service “said Thursday it has spent more than \$2 billion, and the Interior Department says it has spent \$345 million.” The article notes that “the previous record for combined federal firefighting costs was \$2.1 billion in 2015.”

Herbert: Zinke Signaled Grand-Staircase Should Be Shrunk.

The AP (9/14, PRICE) reports that Utah Gov. Gary Herbert “said Thursday that Interior Secretary Ryan Zinke has signaled that he’s recommending President Donald Trump shrink Utah’s two-decade old Grand Staircase-Escalante National Monument.” Herbert “doesn’t specifically know what Zinke has

recommended for the 1.9-million acre (7,700-square kilometer) area of Utah's new Bears Ears National Monument, but the governor said at his monthly news conference, taped at KUED-TV Thursday, that Zinke felt former President Bill Clinton's 1996 declaration of Grand Staircase-Escalante went too far."

BLM: Wyoming Working To Fulfill Trump Energy Agenda.

The Wyoming Tribune Eagle (9/14, Funk) reports that "with a very different energy agenda in the administration of President Donald Trump than his predecessor, the Bureau of Land Management in Wyoming is ready to adapt to those changes," according to Duane Spencer, BLM of Wyoming deputy state director for minerals and lands. Spencer "spoke Wednesday during the 2017 BLM Industry and Government Conference in Rawlins." Spencer said, "We have been working very closely with our Washington (D.C.) office to bring them up to speed on what Wyoming is working on, what resources we offer, and that we believe BLM Wyoming is strategically positioned to deliver on what some of the administration's priorities are – in particular, the goal of making America safe through energy independence and contributing to economic development and local economies."

Protests Over BLM Timber Sale.

KOBI-TV Medford, OR (9/14, Jordan) reports that "an auction for logging rights to hundreds of acres of Bureau of Land Management property drew a crowd of protesters in Grants Pass." The BLM "says the land needs logging to prevent fires." But "protesters were concerned about the thinning of old growth trees."

Deep-Sea Study To Begin Off Southeast Coast.

The Coastal Review (9/14) reports that "a team of scientists is set to launch in the coming weeks a four-and-a-half year study of deep-sea coral, canyon and gas-seep ecosystems in the mid- and south Atlantic." The team will "travel aboard the National Oceanic and Atmospheric Administration's ship Pisces to explore biological features and geological processes, such as corals and naturally occurring gas seeps and the organisms that inhabit them." The Bureau of Ocean Energy Management, the U.S. Geological Survey and NOAA's Office of Exploration and Research are "supporting the study intended to shed light on little-known natural resources of the deep ocean off the Southeast coast."

U.S. And Mexico Set To Sign Landmark Colorado River Water-sharing Deal.

USA Today (9/14, James) reports that "the U.S. and Mexican governments are close to signing a landmark Colorado River deal that will establish rules for sharing water over the next decade and lay out cooperative efforts intended to head off severe shortages." Officials have "scheduled a signing ceremony on Sept. 26 in Ciudad Juárez, officials at California water districts said this week." They said "that formal event will be followed by a ceremonial signing in Santa Fe, N.M., on Sept. 27 attended by representatives from the states involved."

Environmental Groups Challenge Use Of Waivers To Build At Border.

The San Diego Union-Tribune (9/14, Moran) reports, "A coalition of environmental groups on Thursday sued the Department of Homeland Security challenging the use of sweeping power under a federal law to ignore environmental laws in order to build walls, fences and roads on the border." The lawsuit was filed in federal court in San Diego by Defenders of Wildlife, the Sierra Club, and the Animal Legal Defense Fund. The Union-Tribune says the lawsuit "targets a section of the REAL ID Act of 2005 which granted the Secretary of Homeland Security the power to waive complying with federal laws such as the Endangered Species Act, Clean Air Act in order to expedite border security building projects." The lawsuit "contends that the use of the law was limited to a certain time period after it was passed by Congress, and was not meant to be a perpetual tool the government can use to avoid laws." The AP

(9/14) reports the lawsuit “largely mirrors a lawsuit filed by another advocacy group, the Center for Biological Diversity, but the three organizations each say they have hundreds of thousands of members, bringing more attention and resources to a legal fight over one of President Donald Trump’s key campaign pledges.”

Berkeley Gets Black Panther Tribute \$98K.

The Daily Caller (9/14, Krayden) reports that the National Park Service is “giving \$98,000 to commemorate a violent student protest group: the Black Panther Party.” The NPS is “offering money to UC Berkeley so that it might ‘honor the legacy’ of the ‘60s-era organization that preached a communist revolution and upheld black nationalism.”

Angry Mapp Chastises Community For Unreal Expectations.

The Virgin Islands Daily News (9/13) reports that Gov. Kenneth Mapp “led off his nightly press conference on Wednesday with an angry condemnation directed at members of the community he said have unreal expectations about the recovery efforts in the wake of Hurricane Irma.” On Wednesday, Mapp “first acknowledged the death of WAPA lineman Jason Julius before launching into a diatribe about the community’s complaints about the progress of recovery efforts.”
