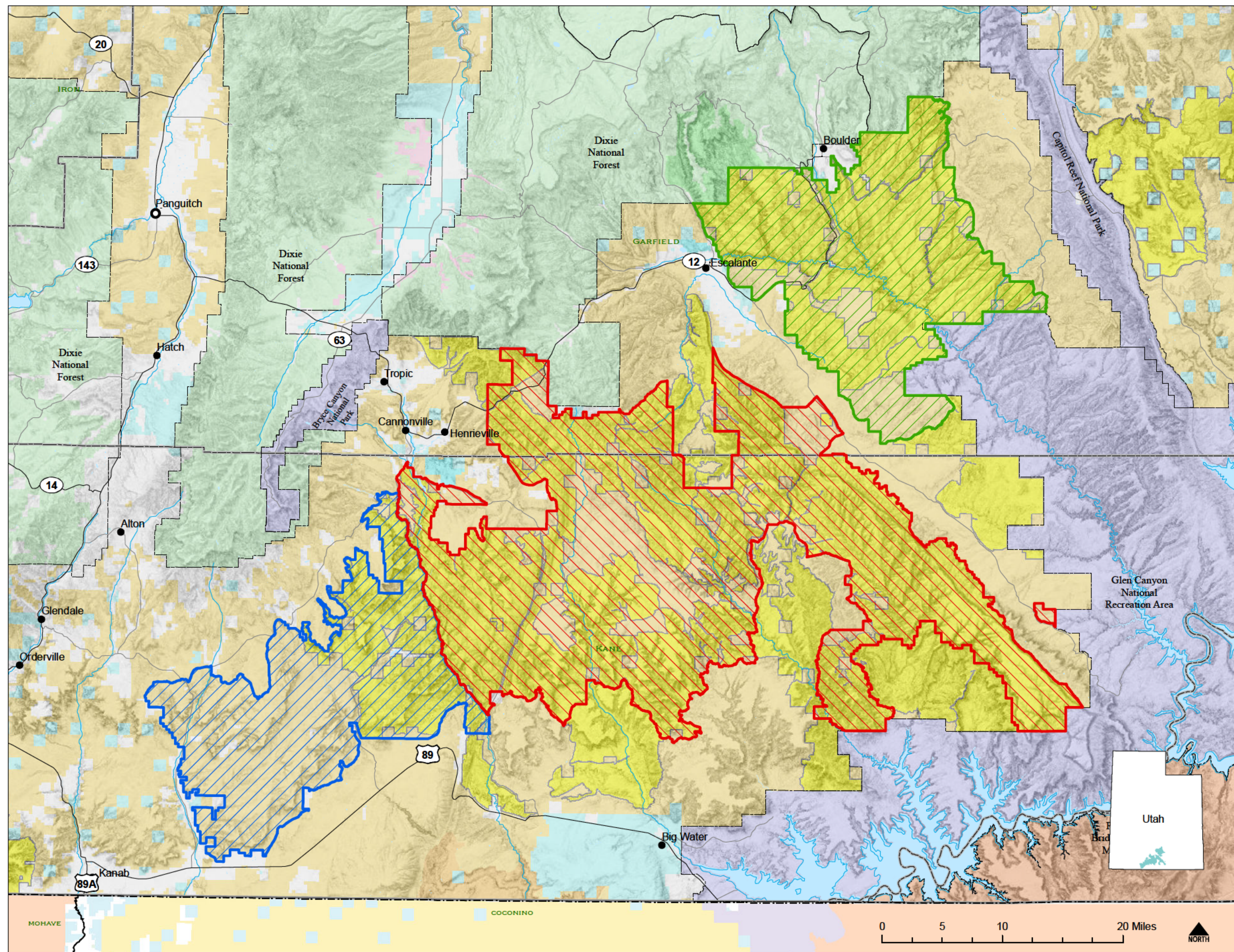

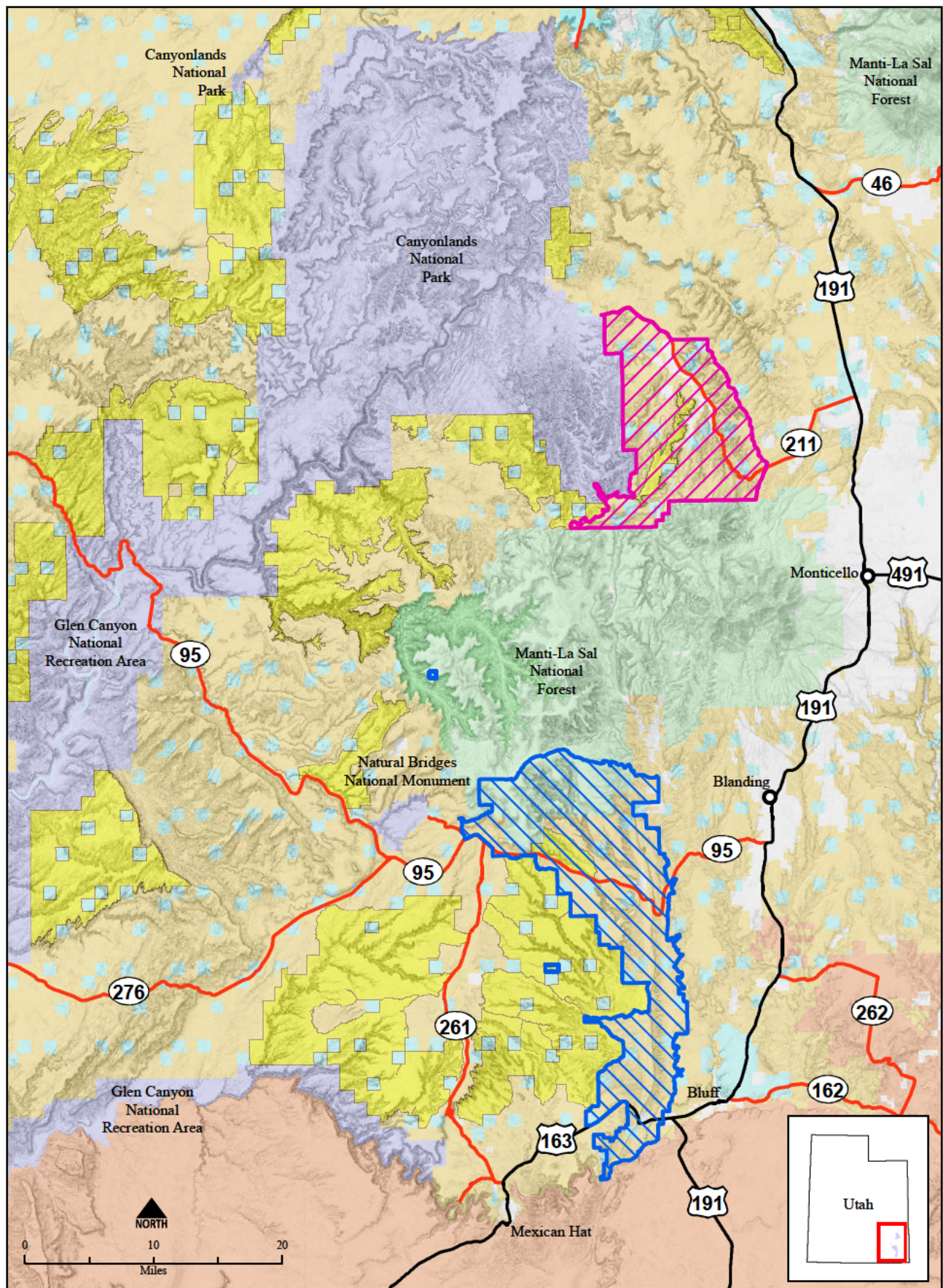

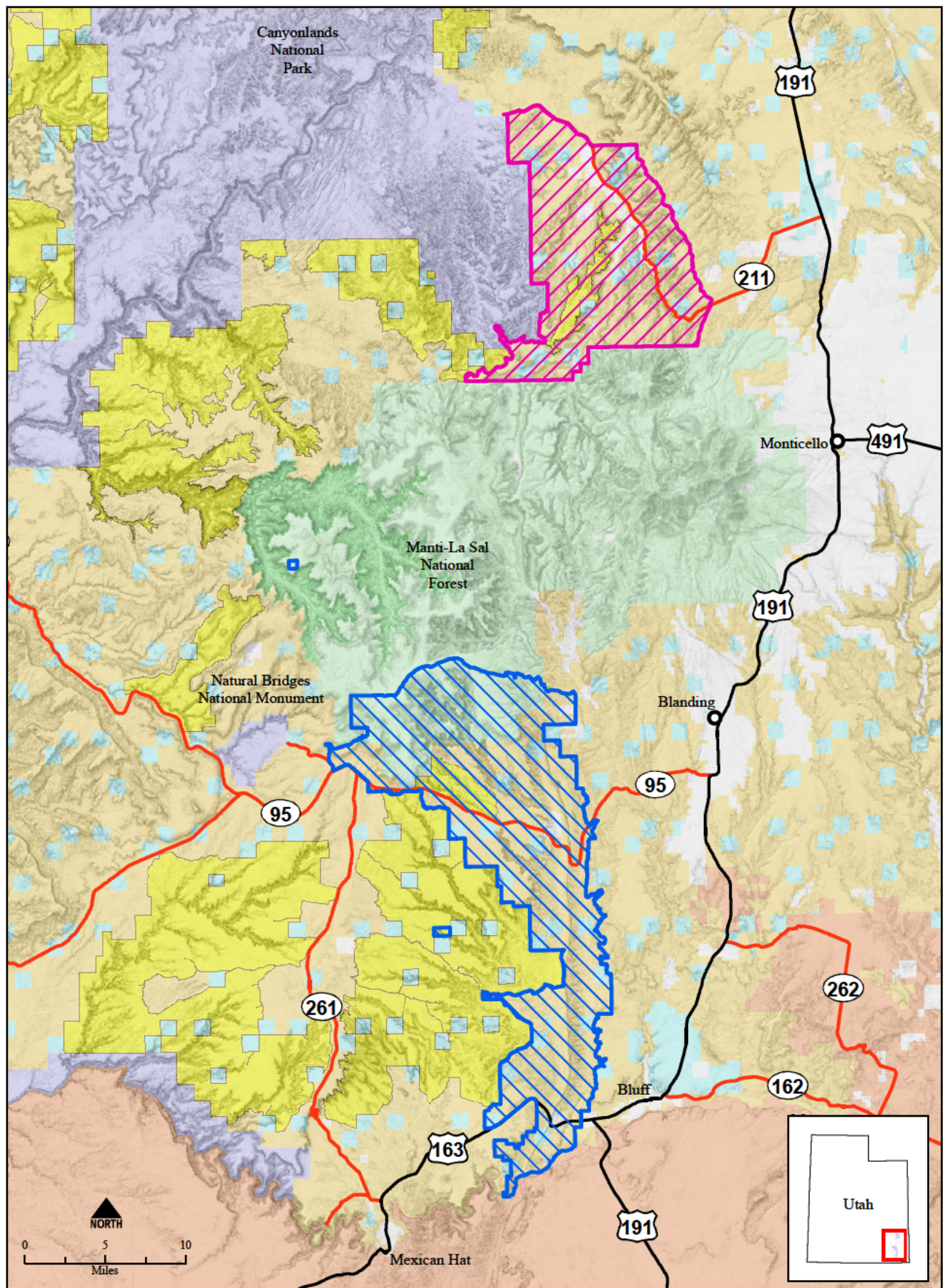
Bears Ears National Monument Boundary Modification
