**VI. Weekly Report:**

**Week Ahead Announcements and Actions**

**On September 7**, BLM-CO will hold an online oil and gas lease sale for 10 parcels totaling 1,227 acres in Cheyenne, Baca, Kiowa, Yuma, Morgan, and Weld Counties, CO. The sale is not expected to be controversial. Bidding is not expected to be robust.

**On September 7**, BLM-AZ anticipates announcing the acquisition of the 600-acre ET Ranch in Southeastern Arizona, through a shared conservation partnership with the Trust for Public Land and Arizona Game and Fish Department. The acquisition will open access for hunters, hikers, and

backpackers to 32,600 acres of Federal wilderness area for the first time and is supported by 20 Arizona hunting and sporting groups.

**On September 7 - 8**, BLM-MT Acting State Director Jon Raby, Deputy State Director Don Judice, District Manager Diane Friez, and Field Manager Loren Wickstrom will join OMB examiners Mike Hagen and Ben Burnett on a tour of the Bakken Region in ND. While in ND they will meet with tribal representatives at the Fort Berthold Indian Reservation.

**On September 7**, BLM-NM will hold an online oil and gas lease sale for 62 parcels totaling 15,731 acres in Eddy, Chaves, Quay, Curry, Roosevelt, and Lea Counties, NM. The sale is not expected to be controversial. Bidding is not expected to be robust.

**On September 7**, BLM-CO will hold an online oil and gas lease sale for 10 parcels totaling 1,227 acres in Cheyenne, Baca, Kiowa, Yuma, Morgan, and Weld Counties, CO. The sale is not expected to be controversial. Bidding is not expected to be robust.

**On September 9**, Kate MacGregor, Acting ASLM, will speak at the 2017 Annual Nevada Mining Association Convention in Lake Tahoe on the Department's priorities with respect to energy and hard-rock mining development. Approximately 550 individuals from the mining industry, vendors and suppliers are expected to attend the convention.

**On September 9**, BLM-WY will host the final wild horse and burro adoption for 2017 in Riverton, WY. The BLM has a 29-year successful partnership with the Wyoming Honor Farm correctional facility in Riverton where inmates gentle wild horses in preparation for adoption.

**On September 11**, the BLM-CA California Desert District is expected to release a summary document of a third party Off-Highway Vehicle (OHV) special recreation permit monitoring pilot project initiated in fall 2016 to local OHV stakeholders. The BLM conducted the pilot project based on feedback from the OHV racing community. The summary highlights the findings of the test pilots and internal and external opportunities to reduce costs of special recreation permits. The summary will be used to guide future discussions between the BLM and local stakeholders about additional pilot projects in the Desert District. Staff for Congressmen Kevin McCarthy (CA-23-R) and Paul Cook (CA-08-R) have been involved with this issue and are working closely with the local OHV stakeholders to identify ways to promote OHV recreation and reduce costs for special recreation permits. This is not expected to be controversial.

### **30 - 60 Day Look-Ahead**

**On September 11**, the BLM will unveil its new Travel and Tourism plan, which is currently under agency review, at the annual American Indian and Alaska Native Tourism Association's meeting in Green Bay, WI.

**On September 12**, BLM's Chief of Recreation and Visitor Services Andy Tenney will attend the annual Recreation One Stop hosted by the Recreation Management Council in Washington, D.C. The RMC is comprised of the agencies participating in Recreation One Stop and Recreation.gov; these agencies include the BLM, Forest Service, Corps of Engineers, Reclamation, U.S. Fish and Wildlife Service & National Park Service. An Interagency Agreement guides the management of Recreation One Stop, including annual meetings of the RMC. Topics for discussion will include the program budget, update of the Interagency Agreement, status of the incumbent and incoming Recreation.gov contractors, and a summary of current and future activities.

**On September 12**, BLM-MT will hold an online oil and gas lease sale for one BLM parcel in North Dakota totaling 2.78 acres and 14 parcels in South Dakota totaling 4,275.29 acres. The sale is not expected to be controversial. Bidding is not expected to be robust.

**On September 12**, BLM-NV will hold an online oil and gas lease sale for three parcels totaling 3,680 acres in Nye County, NV. The sale is not expected to be controversial. Bidding is not expected to be robust.

**On September 12**, BLM-UT will hold an online oil and gas lease sale for 15 parcels totaling 4,438 acres in Juab County, UT. The sale is not expected to be controversial. Bidding is not expected to be robust.

**On September 13**, BLM-AK will facilitate its monthly planning meeting with the Native Village of Nuiqsit and cooperating agencies for the Greater Mooses Tooth 2 (GMT2) project. The agenda includes a GMT2 project status update and preliminary discussions about preferred access road alternatives for the Draft SEIS, which is scheduled to be released this November.

**On September 18**, the public comment period closes for BLM-NV's Oil and Gas Lease Sale Preliminary Environmental Assessment. A competitive oil and gas lease sale will be held on December 12. The BLM received requests to lease 208 nominated parcels of public land, totaling 388,960 acres. The parcels are located in White Pine, Nye County, and Lincoln County. There is no estimate on the number of bidders at this time. There are no known controversies at this time, but they could be identified during the scoping process.

**On September 18**, BLM-MT Acting State Director Jon Raby will meet with Chairman Azure of the Fort Peck Tribes in Poplar, Montana, to provide an update on the status of the KXL Pipeline. This is a government-to-government informational meeting to discuss the Tribe's concerns and questions about the KXL pipeline, such as the proposed route. The proposed route of the pipeline crosses the Missouri River above the intake of the reservation's community water system. The path may also cross areas of cultural significance to American Indians.

**On September 18 - 19**, BLM- MT Eastern District Manager Diane Friez and North Dakota Field Manager Loren Wickstrom will attend the quarterly Fort Berthold Federal Partners Meeting in Lakewood, CO. This meeting will address ongoing issues and challenges associated with Bakken development of oil and gas on the Fort Berthold Indian Reservation, home to Three Affiliated Tribes: Mandan, Hidatsa, and Arikara. Topics include Office of Natural Resources Revenue deduction calculations (royalties, transportation costs and audits); riverbed ownership issues; inter-reservation fee lands jurisdiction; venting/flaring updates, fracking, land buy-back proposals, bankruptcy concerns, Oil & Gas Programmatic Environmental Assessment status, Trust Asset and Accounting Management System training and pipeline Rights-of-Way mapping. The Tribal Chairman and staff will attend along with federal agencies Bureau of Indian Affairs, BLM, U.S. Army Corps of Engineers, Environmental Protection Agency, Bureau of Reclamation, Office of Natural Resources Revenue, and Office of the Special Trustee. The meeting is private and not open to media or the public.

**On September 19**, BLM-MT Acting State Director Jon Raby will participate in the Public Lands Committee breakout session at the Montana Association of Counties annual conference in Bozeman. Forest Service and Montana's Department of Natural Resources and Conservation will also participate. Topics are land management issues such as fire, grazing, energy, and the American Prairie Reserve.

**On September 21 - 23**, BLM leadership will attend the Public Lands Council (PLC) Annual Meeting in Flagstaff, AZ. BLM will provide an agency update during the general meeting, and has proposed a signing ceremony for the Monitoring Memorandum of Understanding with PLC during this session. In addition, BLM managers will present Stewardship Awards for 2017.

**On September 22**, BLM-MT South Dakota Field Manager Chip Kimball and Range Management Specialist Carmen Drieling will attend the annual South Dakota Stockgrowers Convention in Rapid City, SD. This annual meeting brings managers of federal land management agencies in South Dakota together with ranchers to discuss current issues. The meeting will be an open forum for ranchers to ask questions of the agencies. The public and the media are invited, and local U.S. Forest Service managers will also attend. An agenda will be available within a couple of weeks.

**On September 24-30**, BLM-WY Associate State Director Larry Claypool will represent the U.S. government in the Energy Innovation Study Tour at the request of the Canadian government. Larry will visit Winnipeg, Thompson, Estevan, Regina, Fort McMurray, and Calgary to meet with Canadian

government and energy industry officials to discuss innovations in the oil and gas sectors, carbon capture and the overall energy relationship between Canada and the United States.

**On September 25 - 27**, BLM-MT Acting Associate State Director Mary D'Aversa will attend the Roundtable on the Crown of the Continent Conference in Choteau, MT. The Roundtable addresses challenges to the Crown of the Continent such as environmental issues, growth and development, and the loss of traditional knowledge by providing a forum for collaboration and networking. Participants include Tribes/First Nations, land management agencies, local governments, private land partnerships, academia, conservation groups, businesses and industry.

**On September 27**, BLM-NV's Mojave Southern Great Basin Resource Advisory Council is scheduled to hold a meeting at Rainbow Library in Las Vegas.

**On September 30**, National Public Lands Day, the BLM will showcase more than 120 projects and is on track to mobilize approximately 10,000 volunteers in support of those projects. The BLM is developing a website that will enable prospective volunteers to locate BLM projects in their areas.

**In late September**, BLM-UT's Canyon County District and the Manti-La Sal National Forest intend to approve a mine plan modification for the La Sal Uranium Mine Complex to consolidate plans of operation for several mines, and authorize expansion of operations and phased expansion of exploration. The decision will include additional safety, environmental protection, and reclamation measures and monitoring requirements. The project is expected to generate 80 to 130 jobs.

**On October 12-13**, BLM-NV's Sierra Front-Northwestern Great Basin RAC is scheduled to hold a meeting at the Winnemucca District Office.

**On October 24**, the BLM-NV State Office will host a competitive sale of geothermal leases for 18 parcels located in the Carson City, Ely, and Battle Mountain Districts. This will be the first online geothermal lease sale for NV. This lease sale is not expected to be controversial. At this time, the BLM cannot predict the level of bidding interest.
