Nik has asked that I send out a call to any interested OIA staff who would like to help other DOI staff who are coding public comments received about the Monument (Land and Marine) Review. To date, there are over 300,000 comments received through the Federal Register notice.

Coding is fairly easy - the current assignment is to go into system, read individual comments and code into one of 4 categories: 1) For 2) Against 3) New Information or 4) uncodeable.

Later once the deadline has closed, then we will transition to categorizing comments by monument.

Let me know if you'd like to help. Coding takes place at your computer - you can jump on and off the system as time permits.
