We had originally anticipated that there would be a considerable amount of public comment related to the factors set out in the Executive Order for the Secretary to take into account in the review, to which the management bureaus could react, and so did not ask directly for bureau comments on those factors. Several of them were indirectly included or referenced in the two prior information requests, and some bureaus have provided some material on some of the factors in their submissions. However, since the overwhelming percentage of public comments continue to be expressions of personal opinion, Downey would like any information or comments the bureaus might want to provide on these factors for any monument.

This is an invitation to comment, not a requirement. Please provide any comments by COB Friday July 14.

As a reminder, the 7 factors for the Secretary to consider in his review are:

- (i) the requirements and original objectives of the Antiquities Act, including the Act's requirement that reservations of land not exceed "the smallest area compatible with the proper care and management of the objects to be protected";
- (ii) whether designated lands are appropriately classified under the Act as "historic landmarks, historic and prehistoric structures, [or] other objects of historic or scientific interest";
- (iii) the effects of a designation on the available uses of designated Federal lands, including consideration of the multiple-use policy of section 102(a)(7) of the Federal Land Policy and Management Act (43 U.S.C. 1701(a)(7)), as well as the effects on the available uses of Federal lands beyond the monument boundaries;
- (iv) the effects of a designation on the use and enjoyment of non-Federal lands within or beyond monument boundaries;
- (v) concerns of State, tribal, and local governments affected by a designation, including the economic development and fiscal condition of affected States, tribes, and localities;
- (vi) the availability of Federal resources to properly manage designated areas; and

(vii) such other factors as the Secretary deems appropriate. [NOTE - This covers anything a bureau may wish to bring to the Secretary's attention regarding any monument]
