As part of the Bureau of Land Management's (BLM's) ongoing commitment to consult with Indian Tribes, I am writing to inform you that the BLM has initiated a planning effort for the Indian Creek and Shash Jáa Units of Bears Ears National Monument. This planning effort will be supported by an associated Environmental Impact Statement (EIS) prepared under the Council on Environmental Quality (CEQ) Regulations (40 CFR §1500-1508).

Presidential Proclamation 9681¹ reduced the boundaries of the original Bears Ears National Monument, as established in Presidential Proclamation 9558,² to the present boundaries, including the Indian Creek and Shash Jáa Units (please see enclosed map). The BLM's Notice of Intent in the XXXXXXXX XX, 2017 Federal Register initiated a public scoping period to engage the public to help identify issues for this planning effort.

The CEQ regulations at 40 CFR §1501.6 describe the general roles of a cooperating agency. State, tribal, or local entities with jurisdiction by law or special expertise may, by agreement with the lead agency, become a cooperating agency. Additional information on cooperating agency relationships is available at <https://www.blm.gov/programs/planning-and-nepa>. Please note that establishment of cooperating agency status does not waive your rights to protest or appeal the EIS Record of Decision, nor does it replace BLM's obligation to consult with you on a government-to-government basis.

Specifically, I would like to request your input on:

- Any issues or concerns the tribe may have regarding the BLM's management of the planning area;
- Any sacred sites or places of traditional religious or cultural importance to the tribe within the planning area, or needs for access to such places, that the BLM should consider in its planning effort including nomination of potential ACECs through a submittal process provided in the BLM ACEC Manual; and

- Any traditional religious or cultural practitioners the BLM should contact.

If your tribe would like to be a cooperating agency, please fill out the enclosed response letter and return it to Lance Porter, Canyon Country District Manager, at 82 East Dogwood, Moab, UT 84532. Upon receipt of your letter, we will provide a draft memorandum of understanding (MOU) for your review that describes respective roles, responsibilities, and timelines. On the enclosed response letter, please note if the point of contact for finalizing the MOU is different from the point of contact for the planning process.

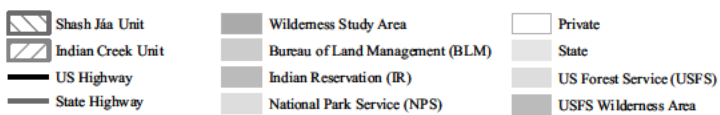
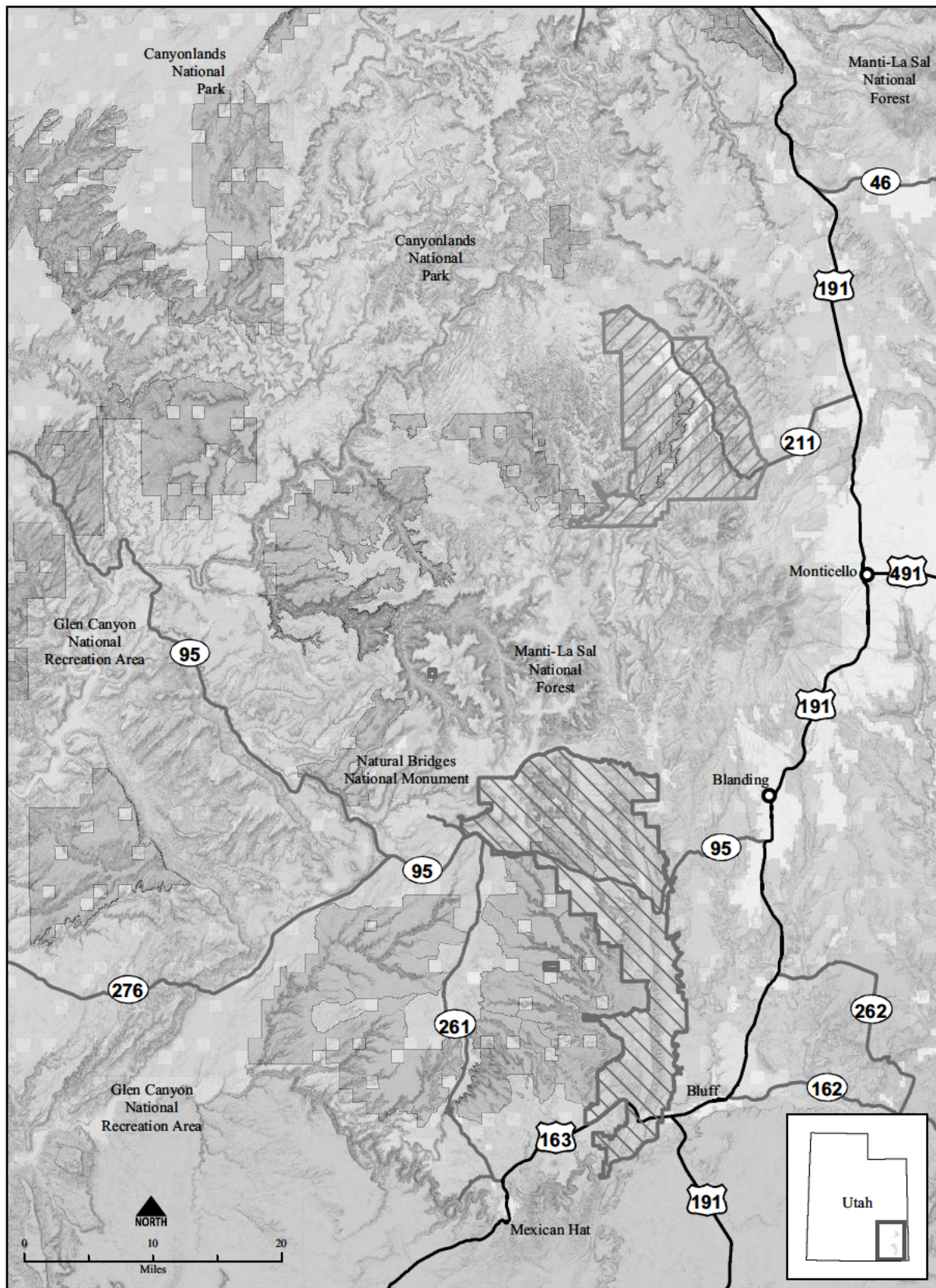
