REQUIREMENTS / RESTRICTIONS / INFORMATION
 The BLM and Forest Service offer the personal use Christmas tree program in a cooperative program to better serve local communities
 Please observe the following permit conditions:

- General**
- ✓ **HARVESTING PERMITTED WITHIN GREEN AREAS ONLY**
 - ✓ One permit is required for each tree.
 - ✓ Validate and attach your permit to your tree before transporting.
 - ✓ Resale of Christmas trees and/or permits is not permitted.
 - ✓ Harvest only on public lands that are open for Christmas tree harvest. Do not cut trees on private property. Do not cut within fenced or posted tree plantations. Do not cut trees within 200 feet of: state highways, campgrounds, and other developed areas.
 - ✓ Harvest only trees that are less than 12 feet tall; keep stump height no more than 12 inches above the ground; and harvest a tree only if there is another tree within 12 feet of it.

- No Harvest Areas**
- ✓ Christmas tree harvest is **NOT PERMITTED** within the **WHITE AREAS**, such as: non-federal land, National Monuments, wilderness areas, botanical areas, or research natural areas.
 - ✓ Christmas tree Cutting is **NOT PERMITTED** within the following BLM or Forest Service managed lands:
 The Wild and Scenic Rogue River corridor
 Recreation areas such as the Table Rocks and campgrounds, Areas of Critical Environmental Concerns (ACECs), National Monuments, and Wilderness areas.

- Vehicle Use**
- ✓ Respect road and area closures. Motorized vehicles are **NOT PERMITTED** on roads closed by gates, earthen barriers or signed as closed to such vehicles. Vehicles shall remain on established roads.
 - ✓ Be aware that others **WILL BE** using the same road (i.e. other harvesters, recreationists, log trucks, etc.). Drive cautiously and defensively. Do Not block, restrict, or interfere with anyone's use of roads or trails.
 - ✓ Vehicle should be clean of mud and plant materials before entry onto National Forest or BLM lands.

- Safety Tips**
- ✓ Always let someone know where you plan to harvest your tree and when you expect to return.
 - ✓ Check weather and road conditions before leaving home.
 - ✓ Be prepared for unexpected changes.
 - ✓ Some public roads are not maintained in the winter.
 - ✓ Carry tire chains.
 - ✓ Carry a saw, shovel, gloves, boots, flashlights, first aid kit, additional water and food, and a rope to tie your tree down on your vehicle.

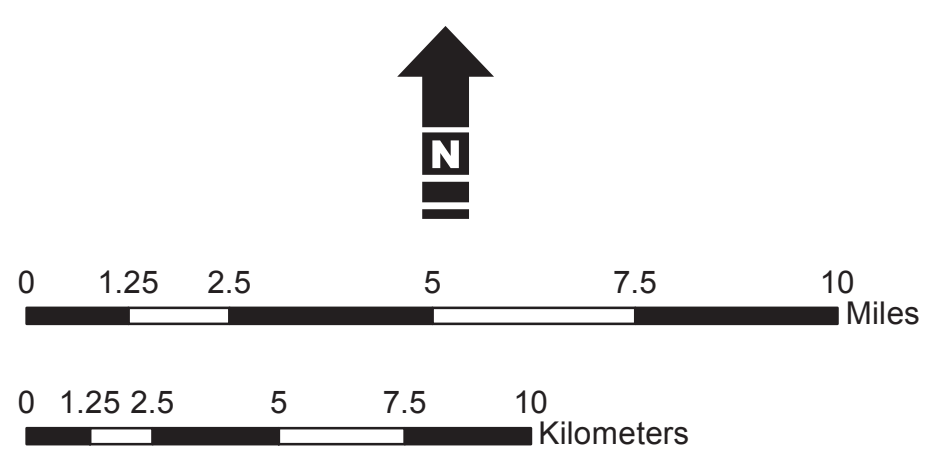

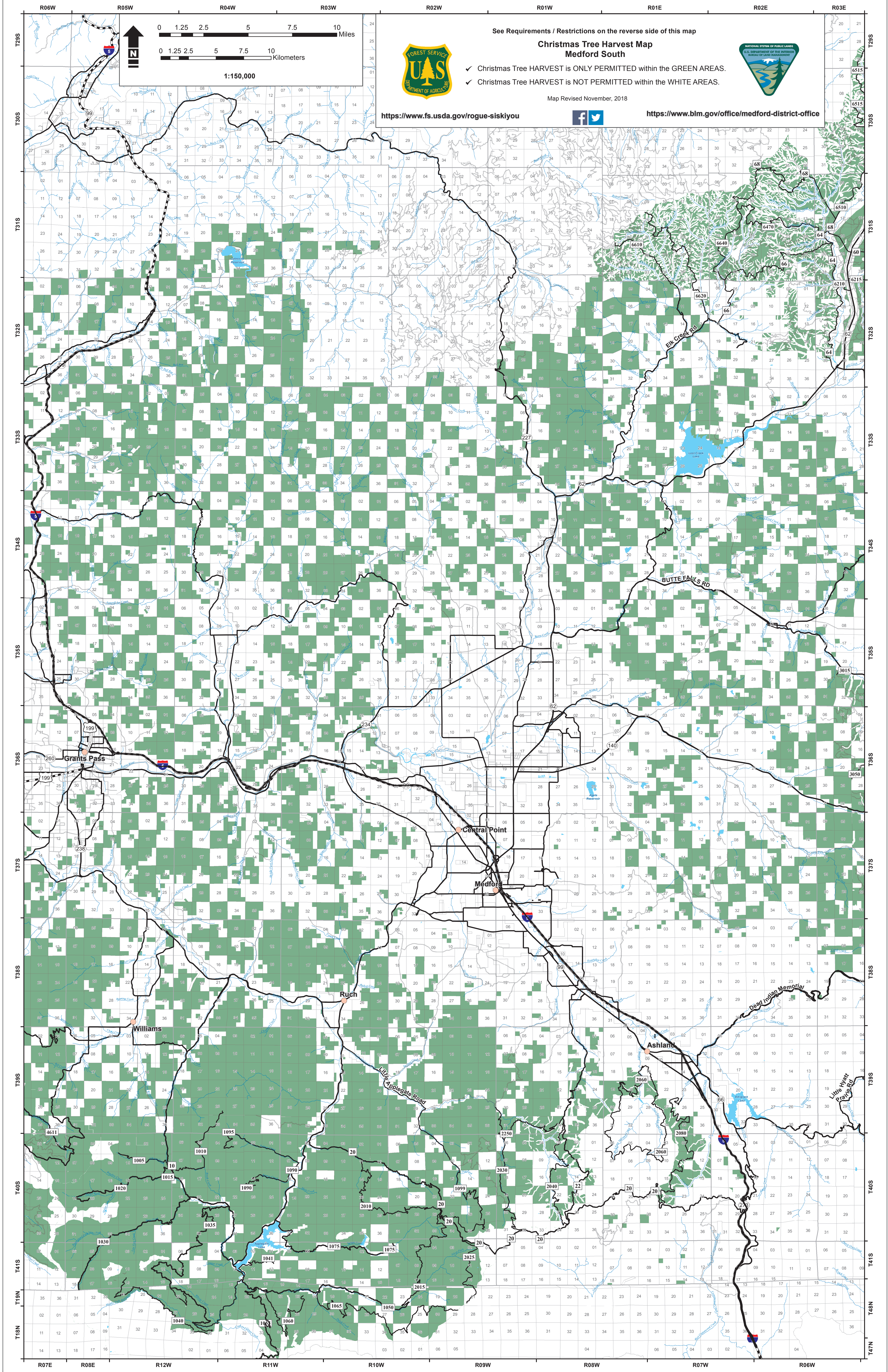

Christmas Tree Harvest Map Medford South

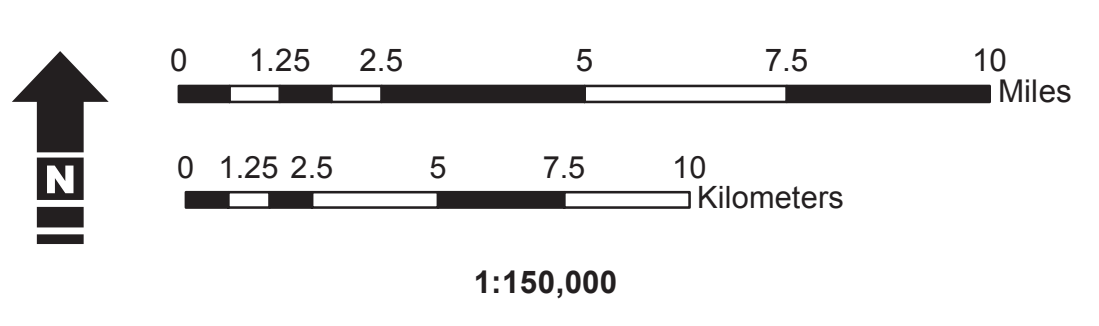
- ✓ Christmas Tree HARVEST is ONLY PERMITTED within the GREEN AREAS.
