Dear Joe,

Please when you have time, I need the answers to my questions below. I will be sending these questions and comments-----along with additional information that was left out at all of these hearings-----especially the connections between these major land developers—Sun Belt Holdings, Shea Homes—one in the same , Trilogy-all three connected and Diamond ventures, also connected to all the others and then to the City of Peoria and the city council members, and the City of Peoria and the lies and hidden facts that were never presented in an open hearing to this point in time. I have spoken to two of the three congressman and they were fully UNAWARE of some to the information I just now provided them and will be contacting the third one—as soon as his mail box opens up and someone answers his phone..... AND HAVE NOT RECEIVED ONE COPY –ONE DOCUMENT-----ONE RECORDED MEETING OR E-MAIL-----NOTHING –ZERO-----AND UNDER FEDERAL AND STATE LAW-----UNDER THE FREEDOM OF INFORMATION ACTS----I, AS IS ANY CITIZEN—ALLOWED TO HAVE COPIES OF ANY AND ALL DOCUMENTS REGARDING THE INVOLMENT OF THE CITY OF PEORIA AND THE CITY COUNCIL AND ANY EMPLOYEE'S OF THE CITY-WITH REGARDS TO THESE POWER LINES AND THEIR PLACEMENT, SUN BELT HOLDINGS AND DIAMOND VENTURES, THEIR EMPLOYEES AND SPOKES PERSONS SUCH AS Lynda Reitman.
