Again we thank you for your reply---at least this time there are no threats and insults -but you still did not answer what you can with out having to go through forcing you and others to follow the law. I do not think there are any documents that will show us just what your responsibilities are and what you were involved with concerning the Sun Valley to Morgan transmission lines but you can continue to make threats and hide behind others and your choice.-----

Please note when one is investigating hidden and lied about issues-----one must have all the information from all the co-operating agencies in this matter and a perfect example would be the City being in violation of Arizona law-----and hiding the information, lying about the information, not addressing what the public has a right to know-----and what they are not telling us-----certainly affects what we want to find out from you and your agency

THAT WE ARE LEGALLY ENTITLED TO HAVE AND YOU AND YOUR AGENCY-BEING A TAXPAYER SUPPORTED AGENCY AND FUNDED BY THE CITIZENS AND TAXPAYERS OF ARIZONA---DID NOT HAVE THE COMMON COURTESY TO PROVIDE US WITH THE INFORMATION SO WE COULD DIRECT OUR QUESTIONS AND CONCERNS TO THE PROPER DIVISION AND PEOPLE-----
