Please read the e-mail --MINE, reply to Mr. Cardines e-mail. We have been asking for copies of information-----COPIES OF VERY SPECIFIC INFORMATION, DETAILS, FINANCIALS, MEETINGS, MINUTES, NOTES, COMMUNICATIONS, LETTERS, YOU NAME IT, FOR MONTHS NOW AND FROM VERY SPECIFIC PARTIES IN THE MATTER OF THE DESTRUCTION OF BLM LAND ON THE NORTH SIDE OF RTE 74-----WHEN WE KNOW THE SOUTH SIDE IS SLATED FOR COMPLETE DESTRUCTION -----SO IN EFFECT BOTH SIDES OF THIS LAND WILL BE DESTROYED FOR THE USE OF THE PROTECTED DESERT TORTOISE AND ITS HABITAT----- WHEN THE BLM REFUSES THE USE OF ITS LAND ON THE NORTH SIDE WHICH HAS BEEN DONE ALREADY-----AT LEAST HALF WILL BE PROTECTED-----INSTEAD OF FULL DESTRUCTION ON BOTH SIDES. ANYWAY

WE DEMAND THE COMMENT PERIOD BE EXTENDED AND NEW HEARINGS HELD TO INCLUDE INFORMATION, DOCUMENTATION, NEW DETAILS AND ISSUES THAT HAVE NOT BEEN DISCLOSED AND HIDDEN FROM THE PUBLIC AND FULL NOTIFICATION AND DISCLOSURE - WHICH IS REQUIRED BY LAW-----IS DONE LEGALLY AND PROPERLY-THANK YOU.

We have been told now for months-----that our requests and e-mails have been forwarded to you and others-----and just today have we been informed.

This delay and purposeful delay and the hiding of information is totally unacceptable and illegal. Mr. Cardine has been aware and has confirmed you and others have been fully informed of our requests for some time now-----which is clearly not the case as of today.

I can send you all of our specific requests that we sent to Mr. Cardine-----which we now have been told you are just being informed. On top of that-----we had a most recent situation of asking questions of a state employee from the Arizona State Land Department and rather than answer the

questions-----threatened citizens of the state of Arizona and refused to answer any questions-----
-----This is the same tactic Mr. Cardine has used, the ACC, the City of Peoria and now you and your
office-----as you have not at anytime responded to our requests and demands for information under
the Freedom of Information Laws of the United States of America. This and what has been going on is
deplorable and illegal.

Anyway-----please read the e-mail below that we sent to Mr. Cardine-----and now you-----
---and all the other e-mails that we have been sending for months now-----we will be re-sending
them to you just in case. We have been very specific in our requests-----VERY SPECIFIC-----
and until we receive everything-----can analyze

THE COMMENT PERIOD MUST BE EXTENDED AND NEW HEARINGS MUST BE
HELD IN ORDER TO INCORPORATE AND DISCLOSE THE EXTREMELY IMPORTANT

Hello again, [Redacted]. The Sun Valley to Morgan is a BLM Arizona project, and as such, Washington has not been directly involved. However, there is a list of contacts in the national BLM website (www.BLM.gov), and you should feel free to contact anyone you would like to there.

The pertinent managers are the two line managers who will make the decisions on this particular project. They are reading the emails, hard copy letters, petitions and other comments that are coming into BLM, prior to their making their respective decisions. You may recall that the decision-maker names were provided in the powerpoint presentations at the three public meetings that you attended on the Draft EIS (Peoria, Wittmann, Phoenix). I am including their telephone contact information below as requested.

Rem Hawes, Hassayampa Field Manager, decision-maker on whether or not to issue the ROW to APS on public lands, (623) 580-5530. You may recall that he was present at all of the public hearings we held in December. However, as you and I discussed, State Trust lands will be making all decisions that involve their own lands, near the area of concern in the Wittmann community. Mr. Hawes reports to the Phoenix District Manager, Ms. Mary D'versa (623-580-5580), who reports to Mr. Suazo, whose information is below.

Raymond Suazo, AZ State Director, decision-maker on whether or not to amend the resource management plan to designate a utility corridor on public lands on the north side of SR 74, (602) 417-9500. He is the lead person for all BLM in Arizona.

Regarding the case files for each realty action you refer to - this documentation is contained in the official case files in the following offices, and is public record for these previous BLM actions:

The information on the APS/Quintero Transmission line can be found in the case file for AZA-31728, which file is located in the Phoenix District Office, 21605 N. 7th Avenue, Phoenix, AZ 85027.

The information on the land exchanges on the south side of SR 74 that you are referring to are located in the case files for cases AZA-23254FD (Seven West Properties) and AZA-29960FD (Tucson Mountain Investors). These case files are located in the public room at the BLM, Arizona State Office, One N. Central Avenue, Suite 800, Phoenix, AZ 850004.

As stated in my previous email responses to you, the Draft EIS, which document has been provided to you at the beginning of the comment period, answers your project-related questions that you have been inquiring about:

- Purpose and need, the history of the APS ROW application, the ACC process, applicable laws that BLM has to follow (Chapter 1).
- What alternatives BLM considered and the rationale for analyzing (or not analyzing) each alternative, information on technology related to undergrounding powerlines, etc (Chapter 2).
- The affected environment and impacts to people and resources for BLM's preferred alternative and other alternatives (Chapters 3 and 4).
- BLM's public notification process for informing the public through media, letters and postcards, flyers in the communities, etc (Chapter 5).

I hope this helps you. We would appreciate any comments you have on this document by February 8th, which formally ends the required 90-day comment period. Your substantive comments regarding agreement or disagreement with the information presented in the Draft EIS, alternatives we considered (or didn't), etc on this project would be most appreciated by BLM, as we examine all comments and move to a Final EIS.
