MY name and contact information is below and I am seriously involved with all aspects of the APS power lines regrading the APS Sun Valley to Morgan route and the many options that all parties have in the route that will ultimately be used.

As an employee of the Arizona State Land Department---an agency formed and paid for by the citizens of the State of Arizona, and working for the people and taxpayers of Arizona, I find your reply to Mr. [REDACTED] a little disturbing on a number of fronts.

If Mr. [REDACTED] or anyone has made some mistakes in who they and others contact regarding the APS transmission lines and the routes and land used----please accept our apologies. We are fully aware of the issue of the BLM and what they have not done, legally and illegally, what they are legally required to do and did not do, the hidden agendas and mis-information, the purposely hiding of details and information---hearings not open and honest and not disclosing numerous facts and issues that the public has a right to know, and all of this certainly involves the use of state land for this project----

I would suggest by the tone of your reply that the State Agency of the Arizona State Land Department--condones what has taken place by the BLM and others, and maybe fully involved in these cover ups and mis-information, lies, the hiding of facts and just wants to try and threaten the people of Arizona --taxpayers, the very people who support your agency and try and get them to go away ?????/

BUT----maybe you should have replied back with the correct contact information regarding who we

should contact with regards to the use of State land in this very serious matter. As I notice your title is ROW Section Manager-----maybe an explanation of what exactly is your responsibility in the matter of state land being used on the numerous routes that are under consideration---- and if your responsibility in this matter has nothing to do with the issues we are trying to raise-----AND MAKE NO MISTAKE--- the BLM issue encompasses the use of State Land in this project from Sun Valley to Morgan----

WE APOLOGIZE FOR MAYBE NOT MAKING OUR SELVES PERFECTLY CLEAR----- so maybe you can direct us to the proper contact people such as the Director of the Arizona State Land Department and others that we failed to contact and contacted you by mistake . thank you We look forward to the correct contact information.

A few comments by me personally-----and you can direct any and all replies to me-----

- 1.] we are aware of the BLM and the mistakes they have made----which involves the use of State land and your agency
- 2.] we are demanding new hearings and an extended comment period---and maybe you should of just thought of our contacting you-as a mistake but also notice and a heads up. Always look for the positive as I say.
- 3.] If the BLM made serious mistakes and the City of Peoria and others---which we know they have and brought to their attention-then the ACC and APS and the the Department of Arizona State Land has also-as you were given false and misleading information, given lies and certainly not fully informed to make a proper and intelligent decisions as to the routes and proper use of state land.
- 4.] I would hope to hear back from the State Attorney General Office with regards to your legal counsel and the guidance you have or will be given-----We also look forward to talking to the Attorney Generals office.
- 5.] The threat made by you with regards to the people of Arizona wanting to get involved in THEIR ISSUES---with regards to THEIR MONEY----- and THEIR HOMES and THEIR LIVES and THEIR FUTURES--THEIR HEALTH, is something that maybe you could have addressed by suggesting the proper state employees, directors, head of an agency, and proper state agencies, the attorney general, maybe the governor, whom ever, so their concerns can and will be properly addressed and not threatened.
- 6.] You last statement ---YES,-we have questions, and yes we want to discuss the use of state land and we will be seeking copies----under the freedom of information laws of the Sate of Arizona----with regards to the whole issue of state land being used , and did the State issue a EIS report of its own on land held in trust for all the people of Arizona, regarding the routes the state might use in the future.?? ?
- 7.] both the BLM and the City of Peoria have violated both State and Federal law under the Freedom of Information Acts that all government agncies must abide by---your agency also.

Once we have ALL the correct contact information about who to contact and discuss these serious matters -and it is clear we made a mistake in contacting you as you have nothing to do with the issues--NOT JUST THE BLM--we will be more then happy to remove you from our contact list.

We greatly appreciate your help in these matters and sorry for any inconvenience this might have caused-----As an employee of the sate of Arizona, one would hope that you are more then willing at all times to help the citizens of the State of Arizona and the taxpayers ---to possibly right some wrongs that need the attention of the Department of Arizona Land-for which you work for.
