We have been trying for months now----going on 18 months or more, years when it comes to the City of Peoria, for information, details, financials, communications, written or other wise, documents that were hidden from public view and scrutiny by the very public that was supposed to be informed over the years by public hearings----- NOTHING CAN BE FURTHER FROM THE TRUTH

Recently -going back to last year-----we began to ask for information and details that was purposely hidden or not made public-----even worse-having paid federal and state and city employees claiming that they did not know, were not informed, , and again even worse on their parts-----they never attempted in any way shape or form-to find out the information that the public was and is entitled to by law.

They--the city, the state and the federal employees----- just pleaded ignorance and the old phrase of

Sgt Shultz of the old TV series-Hogans Hero's-----I know nothing-I know nothing-and did nothing more except to plead stupidity--ignorance and go about what they were all doing from day one----- not notifying the public, lying, hiding information, making false statements, protecting each others behinds and thinking people who have a right to know

The BLM in Utah-----from day one has instructed us to at all times to go through them for information, facts, the truth, with regards to questions and comments-----but they never answer any questions-and just recently after some 18 months having been totally assured they were forwarding our question's and comments-----LOW AND BEHOLD-----FROM THAT OFFICE IN UTAH-- --NO ONE ELSE HAS RECEIVED ANYTHING --NOTHING WAS FORWARDED AND NOW SOME PUBLIC RELATIONS PERSON CONTACTS US ABOUT A YEAR LATER-----CLAIMING HE KNOWS WHAT WE SHOULD DO-----BUT HE IS NO EXPERT ON ANYTHING ABOUT ANY OF THE ISSUES WE HAVE RAISED AND JUST OFFERS A TOTALLY STUPID REPLY TO DELAY THINGS EVEN FURTHER-----

So-we started recently to e-mail the BLM office in Washington D.C, the director, asst. directors, legal adviser's and seems they too will not reply-even to confirm they are in receipt of the e-mails we have sent directly to them.

This goes for APS and the Arizona ACC and the Arizona Land Department and the City of Peoria----- they are the worst offenders to this point but the others are fast approaching their total disregard to the public which they are supposed to be serving and protecting.

Anyway **THE DIRECTOR OF THE BLM THE WHOLE AGENCY-----MUST ALLOW A GREATER COMMENT PERIOD IN ORDER TO ALLOW THE AMERICAN PUBLIC TO OBTAIN THE INFORMATION, THE DETAILS, THE FINANCIALS, THE COMMUNICATIONS, THE DOCUMENTS, THE STUDIES REGARDING FEDERAL AND STATE PROTECTED ENDANGERED PLANT AND ANIMAL SPECIES, AND I CAN GO ON AND ON-----**

**THIS EXTENDED COMMENT PERIOD AND THE REFUSAL BY THE BLM TO THE USE OF THEIR LAND-BLM LAND----FOR THE PROTECTION FOR THE AMERICAN PEOPLE---THAT THEY ONCE REFUSED USE OF BACK IN 2010-MUST BE DENIED TO APS-MUST BE DENIED----AND THE APS APPEAL---AS THIS WILL PROTECT AT LEAST HALF OF THIS AREA --AS THE OTHER HALF WILL SOON BE TOTALLY DESTROYED ANYWAY THROUGH DEVELOPMENT IN THE NEAR FUTURE**
