Description of Proposed Action: The Salt River Project A I & P D has requested to renew its existing authorization for a 230kV electrical power transmission line and access and maintenance road. The right-of-way is 85 feet in width and 0.08 miles in length, approximately 0.92 acres.

Lower Gila Resource Area processes a variety of land actions in the Lower Gila South RMP/EIS area - rights-of-way, communication sites, easements, permits, and unauthorized occupancy. All land cases would continue to be evaluated on a case-by-case basis.

**C: Compliance with NEPA:**

The Proposed Action is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with 516 DM 2, Appendix 1, or 516 DM 11.5: E.(9). Renewals and assignments of leases, permits, or rights-of-way where no additional rights are conveyed beyond those granted by the original authorizations.

This categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. The proposed action has been reviewed, and none of the extraordinary circumstances described in 516 DM 2 or 516 DM 11.5 apply.

I considered: The proposal is to renew an existing authorization where no additional improvements are anticipated. Therefore, no pertinent design features have been incorporated into the project design, and therefore there is no potential for significant impacts.
