



The six maps represent existing routes recorded during the BLM inventory between 1990 and 2006:


1. Bullhead

The maps were revised following public input during comment periods and these six maps represent the complete inventory contained in the Lake Havasu Field Office, Record of Decision, Approved Resource Management Plan, May 2007.


With the exception of constructed and maintained highways, paved roads and streets within communities each route has been located using the Global Positioning System (GPS). Each route was confirmed, by one of the following methods: foot, horseback, dirt bike, ATV or other 4x4 vehicles. An identifying number is assigned to each route.

Routes shown on these maps merely represent ways of travel at a given time. No presumptions are implied for the reader regarding types of OHV necessary, climate, terrain or other conditions that may affect public safety.

These maps display the inventory of existing routes available for travel and identified as "Limited to Existing Roads and Trails" contingent upon the Travel Management Plan(s) TMP completion. The purpose of the TMP is to use a systematic process of evaluating routes and designate each route open, limited or closed. Routes created after the ROD/Approved RMP, are not legal and are not considered during the TMP/designation process. See below for more information on the designation process.

WHAT COMES NEXT?

BLM began the Travel Management Planning (TMP) process with public meetings in the fall of 2006 for the Bullhead Travel Management Area (TMA). BLM is gathering data, comments, issues and concerns for the analysis of each route.

The Travel Management Network (TMN) will establish a network of open, closed, or limited routes providing reasonable and environmentally sound access to public land. The TMN will include opportunities for a variety of motorized and non-motorized access and seek a balance of the wide spectrum of resource values found on public lands.



AZ BLM has adopted the Route Evaluation Tree (Tree) for designating routes and developing the TMN. The Tree and other basic evaluation criteria can be found in Travel Management, Appendix L in the ROD/Approved RMP.

The Tree applies a set, analytical method to all inventoried routes to determine whether they should be part of the Travel Management Network and if any limitations are necessary to protect or enhance recreation, cultural, and/or natural resources.

LHFO will systematically evaluate the routes depicted in the six Travel Management Areas. When the evaluation process is complete for each unit, the information will be placed on the internet and at public locations (i.e. libraries) for public review and comment. The draft Travel Management Plan will present four alternatives (including the no action) for each unit. The final Travel Management Plan will designate each route as Open, Limited or Closed for motorized use. The plan will also identify routes to be open for non-motorized use. Once all travel management units are completed the six access guides showing the final travel management network will be published to implement the Travel Management Network replacing any previous maps.
