

KIAVAH WILDERNESS

42,562 Acres

***Designated October 31, 1994 by the California Desert Protection Act,
Public Law 103-433***

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Kiavah Wilderness Area located in Kern County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

Unit 1

From the corner of sections 22, 23, 26 and 27, T. 25 S., R. 36 E., Mount Diablo Meridian, this point being the point of beginning;

thence northeasterly to point 1, the intersection of a line parallel with and 30 feet southwesterly of the centerline of a jeep trail and a line parallel with and 30 feet southeasterly of the centerline of a jeep trail, said intersection located near the southwest 1/16 corner of section 23;

thence southeasterly, parallel with and 30 feet southwesterly of said centerline to point 2, the intersection of the north-south centerline of the northeast 1/4 of section 26;

thence southerly on said centerline to point 3, the northeast 1/16 corner of section 26;

thence easterly on the east-west centerline of the northeast 1/4 of section 26 to point 4, the intersection of a line parallel with and 300 feet westerly of the centerline of State Highway 178;

thence southerly, parallel with and 300 feet westerly of said centerline to point 5, the intersection of the Sequoia National Forest boundary at the east-west centerline of section 1, T. 26 S., R., 36 E.;

thence westerly, coincident with the Sequoia National Forest boundary, on the east-west centerline of section 1, to point 6, the center 1/4 corner of section 1;

thence northerly, coincident with the Sequoia National Forest boundary, on the north-south centerline of section 1 to, point 7, the 1/4 corner of sections 1 and 36 on the township line between Ts. 25 and 26 S., R. 36E.;

thence westerly, coincident with the Sequoia National Forest boundary, on said township line between sections 1 and 36, 2 and 35, 3 and 34, and a portion of sections 4 and 33 to point 8, the east 1/16 corner of sections 33 and 4;

thence northerly, leaving the Sequoia National Forest boundary, on the north-south centerline of the southeast 1/4 of section 33 to point 9, the center-east 1/16 corner of section 33, T. 25S., R. 36E.;

thence easterly on the east-west centerline of section 33, the east-west centerline of section 34 to point 10, the 1/4 corner of section 34 and 35;

thence northerly, between sections 34 and 35, and sections 26 and 27, to point 11, the south 1/16 corner of sections 26 and 27;

thence westerly on the east-west centerline of the southeast 1/4 of section 27 to point 12, the southeast 1/16 corner of section 27;

thence northerly on the north-south centerline of the southeast 1/4 and the north-south centerline of the northeast 1/4 of section 27, to point 13, the northeast 1/16 corner of section 27;

thence easterly on the east-west centerline of the northeast 1/4 of section 27, to point 14, the north 1/16 corner of sections 26 and 27;

thence northerly between sections 26 and 27 to the point of beginning.

Unit 2

From the corner of sections 7, 12, 13, and 18, T. 26 S., Rs. 36 and 37 E., Mount Diablo Meridian, said point on the Sequoia National Forest boundary, this point being the point of beginning;

thence easterly, between sections 7 and 18, T. 26 S., R. 37 E., leaving the Sequoia National Forest boundary, to point 15, the 1/4 corner of sections 7 and 18;

thence southerly on the north-south centerline of section 18 to point 16, the center-north 1/16 corner of section 18;

thence easterly on the east-west centerline of the northeast 1/4 of section 18 to point 17, the intersection of a line parallel with and 300 feet westerly of the centerline of State Highway 178;

thence southeasterly, parallel with and 300 feet southerly of said centerline to point 18, the intersection of a line parallel with and 100 feet westerly of the centerline of the road to Walker Pass Campground;

thence southwesterly, parallel with and 100 feet westerly of the centerline of said road to point 19, the intersection of a line parallel with and 100 feet northerly of the paved Walker Pass Campground loop road;

thence southwesterly, parallel with and 100 feet westerly of the centerline of said loop road to point 20, the intersection of a line parallel with and 30 feet northerly of the centerline of a jeep trail;

thence southwesterly, parallel with and 30 feet westerly of said centerline to point 21, its terminus West of a well;

thence westerly to point 22, the intersection of a line parallel with and 100 feet southerly of the centerline of the Walker Pass Campground loop road and a line parallel with and 30 feet southwesterly of the centerline of a jeep trail;

thence southeasterly, parallel with and 30 feet southwesterly of the centerline of said jeep trail to point 23, a point 10 feet East of a water pipe, located easterly of the Pacific Crest Trail;

thence North to point 24, the intersection of a line parallel with and 30 feet northerly of the centerline of said jeep trail;

thence northwesterly, parallel with and 30 feet northerly of said centerline to point 25, the intersection of a line 50 feet westerly of the westerly edge of the Pacific Crest Trail;

thence northeasterly, parallel with and 50 feet westerly of the westerly edge of the Pacific Crest Trail to point 26, the intersection of the W-E-W 1/256 subdivisional line of section 17;

thence northerly on said line to point 27, the intersection of the thread of a drainage;

thence northwesterly, along the thread of said drainage to point 28, the intersection of a line parallel with and 300 feet east of the centerline of State Highway 178;

thence northeasterly changing to southeasterly, parallel with and 300 feet southeasterly changing to southwesterly of said centerline to point 29, the intersection of the line between sections 17 and 20, said point on the Sequoia National Forest boundary;

thence westerly, coincident with the Sequoia National Forest boundary, between sections 17 and 20, and 18 and 19 to point 30, the corner of sections 13, 18, 19 and 24 on the range line between Rs. 36 and 37 E.;

thence northerly, coincident with the Sequoia National Forest boundary, on said range line between sections 13 and 18, to the point of beginning.

Unit 3

From the intersection of a line parallel with and 300 feet southwesterly of the centerline of State Highway 178 and the line between sections 20 and 21, said line coincident with the Sequoia National Forest boundary, said intersection being the point of beginning;

thence southeasterly, on a line parallel with and 300 feet southwesterly of the centerline of State Highway 178 to point 31, the intersection of the line between sections 26 and 27, T. 26 S., R. 37 E.;

thence southerly, between sections 26 and 27, to point 32, the corner of sections 26, 27, 34, and 35;

thence westerly, between sections 27 and 34, to point 33, the 1/4 corner of sections 27 and 34;

thence southerly on the north-south centerline of section 34 to point 34, the center-north 1/16 corner of section 34;

thence easterly on the east-west centerline of the northeast 1/4 of section 34 to point 35, the northeast 1/16 corner of section 34;

thence southerly on the north-south centerline of the northeast 1/4 of section 34, to point 36, the center-east 1/16 corner of section 34;

thence easterly on the east-west centerline of section 34 to point 37, the 1/4 corner of sections 34 and 35;

thence easterly on the east-west centerline of section 35 to point 38, the center-west 1/16 corner of section 35;

thence southerly on the north-south centerline of the southwest 1/4 of section 35 to point 39, the southwest 1/16 corner of section 35;

thence easterly on the east-west centerline of the southwest 1/4 and east-west centerline of the southeast 1/4 of section 35 to point 40, the southeast 1/16 corner of section 35;

thence northerly on the north-south centerline of the southeast 1/4 of section 35 to point 41, the center-east 1/16 corner of section 35;

thence westerly on the east-west centerline of section 35 to point 42, the center 1/4 corner of section 35;

thence northerly on the north-south centerline of section 35 to point 43, the center-north 1/16 corner of section 35;

thence westerly on the east-west centerline of the northwest 1/4 of section 35 to point 44, the northwest 1/16 corner of section 35;

thence northerly on the north-south centerline of the northwest 1/4 of section 35 to point 45, the west 1/16 corner of sections 26 and 35;

thence easterly, between sections 26 and 35 to point 46, the 1/4 corner of sections 26 and 35;

thence northerly on the north-south centerline of section 26 to point 47, the intersection of a line parallel with and 300 feet southerly of the centerline of State Highway 178;

thence southeasterly, parallel with and 300 feet southwesterly of said centerline to point 48, the intersection of section 1 on the north boundary of T. 27 S., R. 37 E.;

thence southeasterly, to point 49, the southeast corner of section 36, T. 26 S., R. 37 E.;

thence southeasterly, to point 50, said point having NAD 1927 coordinates of 35° 36' 45" N. latitude, 117° 57' 03" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Freeman Junction, Calif.", 1972;

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 61, the intersection of the line between sections 4 and 5, T. 27 S., R. 37 E., said intersection on the Sequoia National Forest boundary;

thence northerly, coincident with the Sequoia National Forest boundary, on the line between sections 4 and 5 to point 62, the closing corner of sections 4 and 5 on the township line between Ts. 26 and 27 S., R. 37 E.;

thence westerly, coincident with the Sequoia National Forest boundary, on said township line to point 63, the corner of sections 32 and 33 only, T. 26 S., R. 37 E.;

thence northerly, coincident with the Sequoia National Forest boundary, on the line between sections 32 and 33, 28 and 29, and 20 and 21 to the point of beginning.

Unit 4

From the intersection of the line between sections 4 and 5, T. 27 S., R. 37 E., and a line parallel with and 30 feet southwesterly of the centerline of a jeep trail, said point on the Sequoia National Forest boundary, said intersection being the point of beginning;

thence southeasterly, parallel with and 30 feet southwesterly of said centerline to point 64, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail, said intersection located near elevation point 4031;

thence southerly, between sections 23 and 25, and sections 25 and 26, to point 116, the corner of sections 25, 26, 35, and 36;

The boundary calls listed herein are in part a result of scaling distances from said quadrangle maps and are not a result of survey. All courses have been depicted upon the above mentioned quadrangle maps and are made a part of this official record. Acreage is calculated from the BLM California State Office ArcInfo wilderness coverage.
