The configuration of the unit resulting from the large number of inholdings has resulted in long, narrow strips of public lands. These strips are highly susceptible to impacts on naturalness. Pipelines, fence lines, land treatment, water developments, and "ways" are fairly evenly distributed throughout most of the unit. The resulting impacts on naturalness is such that further examination for possible wilderness consideration is not recommended.
