BLM needs your comments on the Draft Resource Management Plan (RMP) and Environmental Impact Statement (EIS). When finalized, the plan will provide a framework to guide subsequent management decisions for the next several decades on more than 1 million surface acres and 1.2 million acres of subsurface mineral estate administered by the BLM Grand Junction Field Office. While one of the alternatives is labeled the Preferred Alternative, none of the alternatives represents the final decision. The BLM will use the public comments to help develop a Proposed RMP/Final EIS, which is scheduled for release next winter. In development of the Proposed RMP, the BLM may select various management actions from each of the alternatives analyzed in this Draft RMP/EIS.

The most effective comments will address specific details of the Draft RMP, including methodologies, sources of information, and components of the alternatives. All comments received will be considered during BLM's decision-making process, but only specific comments will be addressed in the Proposed Plan/Final EIS.

We need comments that not only state a preference for certain management actions in the alternatives, but also include rationale for that preference. Please tell us what you think of specific aspects of the alternatives – and why.
